Old Business –

PAC chair update report on the website –

Current thready status of content, many topics are documented and available for review & elaboration by all interested papered OSJA members through the PAC chat on Telegram and Google docs. The need for as many other eyes and editors as members of the assembly desire to participate was once again emphasized by both Cristina and Ross.

Focus is on common law language (not legal codes and statutes) and that everything transparently represents every member of the Ohio State Jural Assembly. PAC Liaison walked the group through the User Experience document and reiterated the ease of access to links for all content and documents; the site will be arranged so that OSJA elected officials will continually have real time editing capability on the website. Ross acknowledged the miscommunication that caused the old website to become scorched earth on August 30th and pointed out that everyone working on recreating this critical vehicle is painfully aware that without a website, The Assembly is essentially stuck in limbo. Mention was made by Michael of the reasonability of time expectations for the newly created website going live.

Ross reminded all that there is an important OSJA policy change proposal for MENTORS included in the framework of the new website. This was highlighted again for consideration of The Assembly. He urged everyone to please note all comments and input before the website is intended to be live very soon with this new structure in place.
