7:02 Ross opens official business meeting and starts recording

Open Old Business – Michele motions, Cristina seconds

Old Business:

-Michele reads minutes from 1/31;

-vote to accept minutes as read: 5 yeas, 2 abstains

-Treasury update from Michael – no changes

-Public Affairs update from Cristina:

-Charley is making huge progress on website; it's getting close to going live;

-regarding resignations – it seems that some people are not clear about what becoming a jurist means, and are not aware of the relationship between jural assembly and common law; when they start hearing common law being talked about in COS meetings, they become uncomfortable;

-Ross says that Nathan has a lot of knowledge and knows his way around a courtroom and he said he would not use common law;

-Cristina adds that the influence a person has over a large number of people in our assembly should be informational or educational only; when egos get involved and when inflammatory rhetoric is used, it can cause members to break away from COS; when this happens, we must be diplomatic and friendly and welcome people back;

-Michael mentions that Stew Peters is calling for citizen grand juries so there is opportunity to organize information campaigns to educate people about common law and what the grand jury system can do;

-Cristina states the Dave Roberts is going on the Truth Tour and we need to be ready with the website soon as interested will be stirred up as a result of the tour;

Close Old Business - Cristina motions, Kat seconds

Open New Business – Michael motions, Joe seconds

New Business:

-water tests:

- Cristina mentions there are pop-ups on the internet from companies wanting to test water for free;
 - Dave wants each county to get their water tested using local companies;
 - Ross asks will the OSJA get scrutinized or get bad publicity by pressing claims in a county for toxins in the water;
 - Cristina says it the role of OSJA to encourage & facilitate direction that each COS would pursue; pressing a claim would be 1 man/woman vs the man/woman who is adding the fluoride to the water, NOT the COS vs the water plant; one approach, for example, is that each COS could get each papered member to request a test and then notice the man/woman adding the toxins;
 - more discussion is had about water and fluoride; Kat will post information about fluoride in *one Peoples BUSINESS Chat Room* on Telegram
- Kat states that CampTruth is doing tests on the affects of shedding on unvaxxed; she will post on *one Peoples BUSINESS Chat Room* on Telegram
