7:02 Ross opens official business meeting and starts recording.

Bivens is read by Ross 3 times; 3 times no;

Robert's Rules of Order will be followed;

Tim says prayer followed by 15 seconds of silence for reflection;

Open Old Business – Michele motions, Tim seconds.

Old Business:

- -Michele reads minutes from 3/28/23; Cristina suggests correction to second bullet item in Old Business: change "was asked to add some members" to "added some members";
- -vote to accept minutes as read: 10 yeas, 2 abstains; 0 nays;
- -Hemp initiative: Kat was not on to discuss further, but Ross directs everyone to the 3/28 meeting recoding where Kat read 3 pages of information; Ross has pulled the 23 minutes of Kat's presentation/discussion from the 3/28 meeting recording and asks if it can be published (on Telegram)?
 - -Cristina says Kat should be consulted since it's her intellectual property; she also says that the website is a good place for publishing as long as Kat agrees; Cristina thinks we should have a place on the website for current events/current projects that counties are working on; other members on the call agree with this idea;
- -Michael no treasury update
- -Cristina with website update: had a bit of a bumpy training session last night; Ross and Michael were also on; making progress but more hands make lighter work; encourages all to get involved because even the smallest efforts would be useful;
- -Ross thanks everyone past/present/future for their contributions to the website;
- -Telegram access: Cristina has not heard from anyone; she still has no admin access to chats to add people or to remove spam;
- -Kathy reminds us that Felicia Beverly will be in Reynoldsburg on 4/20 to present her proven way to pay utility bills a year in advance using negotiable instruments instead of money

from your checking account; it's the normal COS meeting and Felicia will present following the meeting; the meeting won't be streamed, it's in person only; Kathy estimates 15-20 new faces will be at this meeting; Kathy published the date/time/location in **one People BUSINESS Chat Room** in Telegram

- -Ross talks about CSPOA (Constitutional Sheriffs and Peace Officers Association) founded by Sheriff Mack; members pay dues and Sheriff Mack sends them information about the Constitution and their oath to the Constitution; this seems to be helping OSJA in that some sheriffs may be waking up; some have signed on to say that they will be Constitutional sheriffs; Sheriff Mack has shared a questionnaire to send to sheriffs; Cristina and Ross tailored this questionnaire to Ohio and it's ready and available to any county that wants to participate in this;
- -Ross reminds us that the sheriff is the highest elected authority in country; OSJA needs to be in pattern of sheriff recognition/sheriff relationship/agreements/contracts; in perfect de jured world, sheriff committee exists in each county; it's not our job to remove the sheriff; our job is to educate the sheriff so that when OSJA has clout, the sheriffs will know what we expect of them; OSJA will promote the idea that the sheriffs are constitutional;

<u>Close Old Business</u> – Cristina and Joe motion, Tim seconds.

<u>Open New Business</u> – Cristina motions, Tim seconds. New Business:

- -Michael attended a seminar for \$149 in Westerville Saturday and Sunday with Elise; it was a State Nationals meeting (people following David Straight and Bobby Lawrence), but questions were welcome to give people more clarity; Michael is doing his own research into things they mentioned and other groups they mentioned; question of how to drive without license or registration were addressed here; they use legal codes and statutes but then say don't use forms of de facto government; not a clear pathway of using your own governance to establish where your law is; he has addressed his questions about this to the leaders of this group;
- -Ross read splash page for event and asks Michael if he thinks the seminar addressed all it advertised;
- -Michael says Elise was loaded with information; 153 links; 20+ videos; created Telegram room and filled with all this information that will take months to go through;
- -see recording (starting at 34:00 mark) for full transcript of the information Michael relayed and the discussion and feedback that followed;
- -Michael can be Zelled contributions at 513-553-9868
- -Ross adds that when someone new to OSJA asks about State Nationals, his response is always that we (OSJA) are a bottom-up organization and they are a top-down organization;
- -Michael also says that in the presentation, State National and American National were equated; he wants to research this further with Dave; he also heard we should use set of adjectives like non-resident alien individual (alien to DC); so people out there are talking along the same lines with fine differences and he wants to understand the differences;
- -see recording for more conversation about this topic (54:00 mark), which leads into Cristina stating the need to reiterate the process of getting papered; it's on us to make sure people understand what they signed;

- -conversation about use of drivers licenses/documentation takes place among members;
- -Vic discusses confusion on gun purchase form;
- -Cristina will talk to Dave about process of registering his car; she will share more information as she gets it;
