7:11 Ross opens official business meeting and starts recording.

Open Old Business – Ross motions, Cristina seconds.

Old Business:

-Michele reads minutes from 4/11/23; vote to accept minutes as read: 6 yeas, 0 abstains; 0 nays;

-Cristina-Public Affairs update: many people missed a good Monday Public Affairs meeting;

Charley did a live training on how to take Google docs and import to website; we're at a point where we need all people who previously expressed interest in participating in or contributing to specific topics to become engaged to get aspects of the site completed;

-she and Ross want to have graphics selected so when ready, they can copy/paste the Google doc verbiage along with a graphic;

-the site belongs to OSJA and she wants the site to be reflective of all members so again, she encourages people to speak up;

-Kat is not on so no update/discussion on hemp initiative;

-Ross reminds us of the Felicia Beverly presentation in Reynoldsburg on 4/20; Cristina asks Kathy to ask Felicia if it's ok for meeting to be recorded for personal use/reference, not for publication;

-Ross asks if we've seen the news that David Straight and his wife were arrested, which starts a conversation about whether we feel people in OSJA/Committees of Safety are being targeted/pushing the envelope;

-CSPOA survey: OSJA doesn't prevent individuals from sending surveys to sheriffs; Ross wants to meet face to face with sheriff, while Cristina would prefer to send a letter; this is an example of how there can be more than one way to approach something, while both ways have the same end goal;

-Kathy is concerned that sheriffs may take offense to the letter/survey, which starts the relationship off on the wrong foot, which may prevent us from getting what we want out of the sheriff relationship;

-Cristina will post the sheriff survey on Telegram in **one People BUSINESS Chat Room**;

Close Old Business – Cristina motions, Joe seconds.

Open New Business – Michele motions, Cristina and Joe second.

New Business:

- Dave Roberts Common Law training: no one on the call attended, but Kathy spoke to Erin, who said the class was very good;
- Cristina says she's pleased that after multiple feelers in different counties, we have OSJA people who want to learn this information; this increases knowledge for the collective;
