Open Old Business – Kat motions, Kathy seconds.

Old Business:

- -Michele reads minutes from 4/18/23; vote to accept minutes as read: 6 yeas, 3 abstains; 0 nays;
- -Michael Treasury update: Tim made the following donations:
- \$10 to Michael for State Nationals meeting; \$20 to Ross for gas; \$100 for website
- -Michele asks how to make donation if it can't be done in person and if we shouldn't Zelle Michael's personal account?
- -this starts a conversation about how to make electronic donations with transparency, how to set up a OSJA bank account without a SSN, how to make it so we can add/remove people from account if/when treasurer changes to someone other than Michael;
- -this needs to be solved but won't be solved tonight;
- -Cristina motions to table; Kat seconds;
- -Cristina Public Affairs update: she and Ross worked on site last night;
- -Ross displays website and whiteboard and Cristina reminds us again that there is a large amount of data on whiteboard that needs to be reviewed/created and put up on website and we really need people to start working on content;
- -she states that there is a meeting with Charley at 8:15 tonight;
- -the sheriff survey that was posted on Telegram on April 18 in **one People BUSINESS Chat Room** has OSJA letterhead at the top of the document and references to OSJA in the first two lines of the body of the document; everything after the first two lines is all Sheriff Mack's survey; we need OSJA approval for this; Kat motions to accept, and Michele seconds; in the next meeting, we will vote on replacing the original letterhead and original first two lines of language of the Sheriff Mack survey content with OSJA letterhead and OSJA verbiage in the first two lines of the document;
- -Kat Hemp update: project is making progress; a private funder has made a donation that will be used to buy seeds for East Palestine farmers;
- -Ross asks Kat for permission to add images to her 23 minute talk about hemp and to post it on the OSJA website; Cristina adds that she and Ross would like to promote the project by making it a featured project on the website; Kat agrees to it being a featured project but

would like to make a new recording for the OSJA website;

- -Felisha talks about negotiable instruments; she tells us that someone used a negotiable instrument at a USAA bank and got a \$50K deposit; when a hold was put on the funds, he sent 2 affidavits (about 7 pages) and they released the funds with an hour;
- -Miki Klann just did a video that included a person previously from the banking industry who said NIs have always been used; the use of NI is part of NESARA; we can access these funds without tapping into trusts; Felisha would like to get on Miki's show to spread this information far and wide because we need the leaders to have funds to operate with;
- -she called Chase Executive Office and asked for address to send negotiable instruments to since branches can't process them; Chase provided her with an address; she's going to call more banks to get more addresses;
- -Cristina will send Felicia a Telegram link so Felisha can share the documents used;
