7:04 Ross opens official business meeting and starts recording.

Amanda says prayer followed by 15 seconds of silence for reflection;

Bivens is read 3 times by Ross; 3 times no;

Robert's Rules of Order will be followed;

Roll call: 10 in attendance:

Open Old Business – Michele motions, Kat seconds.

Old Business:

- -Michele reads minutes from 4/25/23; vote to accept minutes as read: 9 yeas, 1 abstain; 0 nays;
- -vote on modified Sheriff Survey (see details in 4/25/23 minutes): 10 yeas; some discussion about survey ensues; Cristina points out that the posted survey is intended to be printed and used in person, not used electronically, so format seen online may look better when document is printed;
- -Michael Treasury update: he received an email where Cristina reiterated Tim's donations, and Tim and Karla were copied on that email;
- -Ross asks how Felicia's negotiable instruments will affect the treasury and/or the ability for OSJA to receive donations, and for any general comments on this topic;
- -Cristina believes there needs to be a 2-pronged approach with Felicia in that the OSJA treasurer needs to know how to accept these payments, in addition to generally we as people need to know how to issue these payments;
- -Cristina moves to table any Felicia discussion until anyone does more research and learns more, and asks that if anyone gets more information, that they post it in Telegram;
- -Kat found book called Redemption and put link in the chat; she also proposes we purchase a printer as a group;
- -Cristina offers up her printer and feels magnetic ink is not truly necessary, but specific font is;
- -Cristina will ask Kathy to ask Felicia if she would do a presentation for OSJA;

-Public Affairs update:

- -Ross asks for a volunteer to recite the Declaration of Independence, the Declaration of Unalienable Rights and the Jural Covenant of Office to post on the website;
- -Ross presents a notice that Cristina is going to post on Telegram (one People BUSINESS Chat Room) asking for any and all persons to get involved with building the website;
- -Cristina acknowledges that the Monday evening Public Affairs meeting conflicts with other meetings, but she can't overstate the importance of as many members as possible participate in building the website;
- -Cristina pauses from Public Affairs to point out that there are court cases happening and People who need our prayers and any assistance we can provide; she specifically mentions

Joe's case in Summit county that has gone on for decades and has become so one-sided;

- -Cristina will try to contact Jon Little for help with Joe's case;
- -Website update: Ross presents and Cristina provides status of what is up and working and what is not; general discussion of website takes place;
- -Amanda has updated her sites to reference juralassembly.org and is going to be promoting this site;

<u>Close Old Business</u> – Kat motions, Cristina seconds.

<u>Open New Business</u> – Cristina motions, Kat and Joe second.

New Business:

- -Dave's common law training no updates from anyone about recent applications;
- -Upcoming events:
- -Ross says there is a Felisha presentation in Dayton on May 5th about negotiable instruments; likely the same presentation that was done in Reynoldsburg;
- -News from Counties:
 - -Amanda in Lorain County: they are debating on what to focus on first a lot of people want to go after election boards; they want to use Dave's affirmation process, but no one understands it; affirmation is law process and is the same as affidavit process, which is legal;
 - -Amanda has two documentaries coming out: one on UFOs and Spiritual Movement, and one called Awakening Revolution, which is a 20 parts series about trafficking, the Republic, and all the fraud; one video ties into the next; over 14 hours of content; can be see on her site **awakenandunite.com** tv with a purpose;
 - -Ross says that OSJA site could possibly link to Amanda's page and/or vidoes;
 - -Michael mentions "The Sound of Freedom" from Angel Studios, a documentary on trafficking;
- -Ross and Cristina in Summit County: they attended a meet & greet with Summit County Sheriff in Copley Township; there was a satellite ribbon cutting taking place; they talked to many county workers; mostly family and friends of county workers were in attendance; Ross thought the sheriff was friendly; Cristina feels she and Ross stood out as not belonging with the others there; it was a nice experience just to be present with the de facto and know that they understood there was something going on there that they didn't quite understand; overall it was pleasant and she looks forward to others having similar experiences with their county sheriffs;
- -Dave's Monday night training sessions: Kat says it's going well but a little slow for her since she's been at it for so many years; but it's good and there's a lot to learn;
