7:02 Ross opens official business meeting and starts recording.

Robert's Rules of Order will be followed;

Ross says prayer followed by 15 seconds of reflection;

Bivens is read 3 times by Ross; 3 times no;

Open Old Business – Michele motions, Cristina seconds.

Old Business:

-Michele reads minutes from 5/23/23;

vote to accept minutes as read: 5 yeas, 2 abstain, 0 nays;

-Michael – Treasury update: no update;

-Cristina - Public Affairs update:

There was an update over the weekend that Beverly Wilburn's notice process is for vaccine injuries, though it started out about the mask mandates; website is in a holding pattern; several people offered to work on specific content; she is waiting for that content;

-7 people were papered in Reynoldsburg last week; Ross did a basic presentation on why a person would want to be papered, and then reviewed the 3 documents; in that same meeting, there was a lot of exchange between those present about the need to understand, incorporate and exercise law in our lives; as this topic comes up more often, we are improving our knowledge share;

-links of presentation and meeting are posted in Telegram *one People RECORDINGS ONLY Room*;

-Beverly has gone through the affidavit process based on Jack & Margie's constitutional law process; she has been at this for 2 years and she is excited about the more simple notice process under common law; she is at the point now where she is going to district court buildings to find a room; she is on her 3<sup>rd</sup> notice and is preparing to present her claim (against the public officials who forced the shot) in front of a magistrate; many people are standing with her in this process;

-Ross mentions there was a post on the old website that outlined affidavit process; Beverly and Rebecca (also from Claremont county) and Robin (one of the OSJA founders) perfected this process and posted it; Beverly did a great job following instructions of this process;

-Dave's common law class:

-Michael says Beverly Wilburn is not doing law common to i because she does not know it but she is working with a small group of people helping her with wording to be more aligned with common law;

- Michael mentions a man he knows who wrote a 5 page letter to his company, who sent it to their lawyers, who said he (Kent) did not have to get the shot;
- there was no Dave common law meeting last night;
- more discussion about Michael's situation, about a man who did a resignation of registration (Dave is making a template of these documents), and using cestui que vie for paying bills; see recording for details;
- Michele G. suggests a separate weekly or biweekly meeting to focus solely on notices, negotiable instruments

New Business:

- Ross shared the oath checklist which all public officials must complete before completing oath of office and obtaining a bond; he put this in Telegram *one People DOCUMENTS ONLY Room*; discussion about bonds and oaths take place; see recording;
- more conversation takes place about oath, judges, notices, silver/constitutional money; see recording;
- Cristina will put examples of notices in Telegram but asks that she be consulted first before anyone uses them;
- Michelle reminds us of the Freedom Festival at Guernsey County Fairgrounds June 30-July 2; \$45 a night to camp; Dave will have a booth for common law; Kat posted flyer in *one People BUSINESS Chat Room* on Telegram;
