## The Ohio State Jural Assembly Official Weekly Business Meeting Minutes for Tuesday June 6, 2023 As Recorded by Michele

7:06 Ross starts recording and opens official meeting of OSJA, where we meet to discuss all business and will motion and vote on all matters.

Michael says prayer followed by 15 seconds of reflection.

Open Old Business – Cristina motions, Tom/Joe/Michael second.

## Old Business:

-Michele reads minutes from 5/30/23; Cristina asks for correction: the website is in a slow moving pattern because there are only 2 people who are not website builders working on it, NOT because of anyone "holding up the process";

vote to accept minutes as read: 6 yeas, 2 abstain, 0 nays;

- -Michael Treasury update: no update;
- -Cristina Public Affairs update: no additional updates;

## -Notice process:

- -Michael and Cristina both discuss their hearings; see recording for details, but here are a few highlights:
- -Michael says he wasn't prepared enough to maintain his own court and keep it in common law; he felt he didn't know how to assert his own law; he needs more practice and knowledge, which will lead to more assertiveness; the result was a guilty verdict and a \$450 fee; he plans to speak with Ross/Cristina/Dave about how to proceed;
- -Cristina reminds everyone that in these situations, you must decide for yourself what approach feels right to you and then you must stick to your decision; don't overthink it; focus on staying in honor, always come from a place of peace and always eliminate controversy;
- -Cristina also points out that we will all benefit and become more knowledgeable from hearing others share their experiences and what worked and what didn't work;
- -Ross adds that as we move forward in our common law courts, a draw is actually a win; if you don't lose, that is a victory!
- -Cristina reminds us that Jennifer Goodwin has copyright on the term "law common to i", so we should avoid using that term and just say common law;
- -Cristina asks if anyone has information on resignation of registration, which is separating your all caps entity from the corporation and you are general executor of estate; Michael put this in his documents and filed his documents with Secretary of State; he has receipt that state received the filing; he entered into docket locally but they did not enter it, meaning, they basically would not acknowledge his filing at the state level; the County does not have the right to ignore a document that has been filed/acknowledged by the State;
- -Cristina points out that the key take-away here is this: any jurisdiction that has rules that are repugnant to the Constitution is in violation of common law.

Close Old Business – Cristina motions, Joe seconds.

Open New Business – Cristina motions, Joe/Michele second.

**New Business:** 

- -Ross presents Private Association: Public Presence; OSJA is private but we have a public presence; he reviews item number 5 in the Bylaws Citation: *The Ohio State Jural Assembly Serves These Primary Functions*;
- -this issue is being raised because of a report that a COS member appears to be taking credit for/and giving credit to people outside of OSJA for things that OSJA has done and is doing;
- -Cristina adds that we need to see if bylaws mention that representations that include our collective name should always indicate that every man and woman stands as equal, no one member is above another; is there anything in the bylaws about publicly talking about OSJA?; is there anything that indicates that any sort of promotional material should be approved by OSJA?
- -Ross reminds that is anyone is saying OSJA did something, they need to be sure that what they are saying is accurate; we need to table this until further research of situation is conducted;
- -Michelle asks if ideas for flyers to promote the website can be presented and voted on in these meetings; Ross says yes;
- -Ross asks if anyone from Carroll County ever attends the Tuscarawas COS; Michelle says no;
