Open Old Business – Cristina motions, Michele seconds.

Old Business:

- -Michele reads minutes from 6/6/23; vote to accept minutes as read: 8 yeas, 2 abstain, 0 nays;
- -Michael Treasury update: no update;
- -Cristina Public Affairs update: no update on website;
- -the situation with COS members not consulting with OSJA on wording has been resolved;
- -Ross mentions that we can create new chairs/committees if we wish, such as a Sheriffs Committee or Ways and Means Committee; discussion ensues about what a ways and means committee actually does; we don't need one right now, we just want to get 66 counties up and running on their own.
- -Notice process: it has been proposed that this be reviewed in a separate meeting; Cristina asks for a proposal of another day of the week besides Monday/Tuesday to meet to biweekly to review notices, common law, negotiable instruments, etc.;

- -Dave and Amanda will be in a booth at the Freedom Festival at Guernsey County Fairgrounds June 30-July 2; Dave will be promoting his Common Law Academy and Amanda will be promoting her website; Dave feels that OSJA should have representation there; Ross and Cristina will likely be there; Stuart may possibly attend as well;

New Business:

-Ross presents State Issue 1 that affects Ohio grassroots efforts; this makes it harder to get grassroots

initiatives approved; Issue 1 asks voters if Ohio should "Require that any proposed amendment to the Constitution of the State of Ohio receive the approval of at least 60 percent of eligible voters voting on the proposed amendment instead of a simple majority of 51%."

- -no news from the counties;
- -Cristina mentions Dave is going to Pennsylvania to start up an assembly; Dave has previously interacted with AFR to start up assemblies but he has found a better, more efficient way the Republik, which has been around since 2013;
- -Stuart asks why Dave can't go to Washington to use common law on Trump arraignment/arrest; Cristina says Dave is in fact going and has found a room for court of claim;
- -Ross presents a Rod Class (who is a private attorney general) document that outlines what "we the people" are doing wrong with Trump; Ross will publish the document when it is final;
- -Stuart suggests an automatic onboarding process on the website when an interested person clicks on their state that we may want to use for our website;
