OSJA meeting

Reynoldsburg Ohio.

Thursday, July 6, 2023.

Kathy Brooks opens 7pm

20 minutes chat of information is exchanged small groups. [Noteworthy tone of the conversation: when individuals are responsible for their own actions; no system(s) of debt slavery, usury, or chattel bondage will be tolerated. When people do what is right and tell what is true; defacto legal system of codes and statutes will mitigate away the bad behavior of the guilty; & no longer steal from and imprison men and women who stand for righteousness. A societal shift in thinking is upon us.

In the future after this shift; There will be no more frivolous lawsuits there will be no more running to the courts to complain. There will be no more judges making law from the bench wearing black to honor the dead slave with a birth certificate chattel bond. This eliminates the tricks and traps people fall into presently leading to fines judgments and loss of liberty i.e. Jail.

The only job of our public officials is to uphold our inalienable rights.]

Opening Prayer reflection, and bivens statement. (1 hour Recording begins after old business is opened. Minutes are from the audible portions.)

Open Old business discussion; Cristina: explains the difference between legal and lawful.(Everything in these minutes are paraphrased from a two hour meeting)

Legal in the de facto when you receive a jury summons, why would you respond anything else other than why would I take five dollars per day to sit on your Jury.

You are told by every British accredited registered agent, judges attorneys bailiffs & clerks;

all We are instructed to consider in the decision; is you must only look at the codes and statutes; those codes and statutes do not serve with the people. When we request a common law Jury this is not the case. In a common law Jury you decide whether there was a harm or a trust pass. The participants have asked for their remedy in their affirmations. Affirmation is your statement of truth.

Legal de facto does not apply to the living. Common law is for the living.

Because I am a woman I require remedy if there was a trust pass to me this is what I require as a remedy. And these are written out in our affirmation statements.

Example I was unlawfully detained. My remedy for that is \$10 million a day. This has done damage to me this has done harm to me this has defamed my character. This has put shame on my name and you did it because you claimed that I was not wearing my seatbelt.

I require remedy for that and I also require 12 of my peers to appear in a room. The magistrate presides over the meeting only to agree that the Jury has agreed upon the remedy. That is the only thing the magistrate is there for.

Ross:

Explains if you want to get rid of the abortion clinics in your town at this point being a jurist is not going to help only one we have The backing of the sheriffs which in Ohio we do not know of any constitutional sheriff's. Once we have constitutional sheriffs being a tourist will have teeth.

We need the constitutional sheriffs we don't know how long this will take; need pet papered members who have the experience in law enforcement; when is Assembly is much larger.

This is when the office of the Sheriff will be organically created from the larger membership body. It's probably not gonna happen in a small body like this.

All the notices in the world aren't going to work we need people to stand with us.

Members agree that there is no remedy due to no court of claim being offered with a magistrate to the public under the de facto legalese system.

Cristina: we need 12 people in a jury who understand the difference between codes and statues and The Bar Association who are our foreign interferes.

We need 12 people who are men and women on the land who understand that their Creator gave them to laws do no harm, do not trespass.

Rebuttal.... Is it really that simple?

Cristina: "It is that simple we have been so deceived my hair standing on end.

Once we have sheriffs who are constitutional who have a conscious. A moral compass, and can feel God's presence; to discern the truth; we are going to be much closer; i do believe this is possible. i believe that these sheriffs will grow as fast as God wants them to grow; i believe hat they can grow a conscience."

Stuart Long: (parafrased)so a friend of mine was talking about three types of cops. The first type is the one who is like the pastor wants to fix things wants to be in line with God. The second one was the kid that got beat up in school and wants to be a bully. The third one is the real cop. I don't know what he meant by a real cop. But I see where this all fits together the sovereignty The remedy the sheriff. Common law and a common law Jury to be the jury of the peers to enforce the remedy.

Part of the root of the legalese is to suck us into claiming a title. Sovereign National wife husband mother..... when we claim no titles we are not subject to further interpretation. God created us we are right below God why would we except titles that are below that of which rd creator intended?

What does a juror do?

It is our duty to abolish tyranny. So we set up Jural Assemblies. We set up petite Juries.

There are referrals from Sherriff's other members, affirmations filed, and there is a possibility that those who currently are in those chairs could see things correctly. We all want that.

Seems obvious to us thay know the difference,

Conversation goes back to finding constitutional sheriffs possibly from people who went through the training and then quit because they were not participating in the fraud that our government is at war with the people.

Question of what would happen to court personnel turncoats within the system?; we need to find the honest men and women that will step up and become constitutional sheriffs and deputies.

Question is asked: how do we press a claim? Discussion about court of claims court of claim is being withheld from the people at the present time are public officials do not want to divulge which room to use for court of common claim. Dave Roberts has located one that's in Washington DC Kat points out that Washington DC is not part of the United States. The point is agreed-upon.

Court of claim is where we want to be with a magistrate but the county officials are denying us the ability to even find the correct room to press the claim.

So the jury decides that we have a remedy.

How do we enforce the remedy? It is the sheriff. So I went to harm is done; and the remedy is decided. If the person cannot pay the remedy it could be by sheriff sale.

Kristina suggest that she goes around with a pad of stickers and everything is sold to create remedy for the one the man or woman who committed the harm has remedy. Some of these I believe will be a public apology; Community service etc.

Riding along with the sheriffs is suggested. Discussion circles.

One member tells he did not go through the academy knows defacto will not back correctness.

Long discussion circles....

Board of elections needs us to be involved.

Silent observers are needed. We only elect we do not vote. We need jural assembly and committee of safety

We notice the sheriffs that we are here. And we accept their service under

Reciprocity we recognize the current sheriffs then we create an organic conversation to change

The defacto bribery system to de jur lawful government of do no harm and do not trespass.
