7:03 Ross starts recording and opens official meeting of OSJA, where we meet to discuss all business and will motion and vote on all matters.

Kat says prayer followed by 15 seconds of reflection.

Robert's Rules of Order will be followed.

Bivens is read 3 times by Ross; 3 times no.

Reminder from Ross we are always looking for Pro-Tem moderator, scribe, and bailiff to back up the men and women who act weekly for OSJA.

Open Old Business – Michele motions, Cristina seconds.

Old Business:

-Michele reads minutes from 7/11/23; vote to accept minutes as read: 5 yeas, 1 abstain, 1 nays;

Corrections:

-Kathy: regarding reference to "...the man Bill in a video that Kathy presented...", his name is Bill Hermanson;

-Ryan: comments about Zoom call should be amended as follows:

"can Tuesday Zoom meeting invite be extended to all attendees in Reynoldsburg meeting, even non-papered attendees?"

"no, only papered members can attend OSJA weekly Tuesday 7pm meeting"

"non-papered people can attend the 6:15pm Tuesday call"

-Ross motions to vote on amended minutes, Cristina seconds; vote to accept minutes as amended: 7 yeas

-Michael - Treasury update: no treasury changes; Michael mentions the concept of using alternative tokens of value/an alternative currency that can be transferred into treasury notes;

-Ross mentions 3 upcoming events:

-August: OSJA panel for Clermont County harmed men and women to practice their testimonies;

-August: Joe returns

-September: annual meeting takes place; ideally this is an in-person meeting in a central location, preferably near a highway for easy access for all attendees; Knox County is the center of the state; suggestions for a location are being accepted;

-Ross brings up Kat's suggestion for a leadership meet up via Zoom; he clarifies that "leadership" doesn't mean just the chairs, it means every man and woman in OSJA;

Kat says that the intent is to decide which direction OSJA should take; for example, take down the legal system, go after school boards, grow membership; etc.

Ross reminds that the Sunshine Law initiative is an easy place for counties to start;

-Cristina - Public Affairs update: she and Kat attempted to meet about website; Kat has lots of good suggestions; Cristina and Ross are new to website maintenance/set up so they are learning how to

work it; Ross says once we get the first page the way we want it to look, we can duplicate it;  
Monday evenings are the best day to meet to review website;

-Cristina posted a general document that Nathan proposed for the Sunshine Law in Telegram in **one People DOCUMENTS ONLY Room**

Close Old Business – Kat motions, Cristina seconds.

Open New Business – Ross motions, Kat and Cristina second.

New Business:

-Ross with Dave update: in his search for claims courts, he has discovered that although the court system is supposed to have a court of claims, none will acknowledge it; there is a man in jail that needs help and Dave intends to place a lein on that all caps man and go to court to insist his property be returned;

-Kat suggests we create our own common law court; Ross says OSJA has the right to create our own court, but a sheriff has to be present and on board with what we're doing or it won't work; see recording for discussion details;

-Kat says CSPOA should be involved when we start going to sheriffs; Cristina refers to the Sheriff Mack survey that has the first paragraph amended and that all counties are free to use it;

Close New Business – Michele motions, Michael/Cristina second.

Adjourn – Cristina motions, Kat seconds.
