Discussion was had regarding whether we can cause the de facto to comply with the Constitutional Sheriff's survey; difficulty of locating oaths of offices for judges and magistrates.

Emphasis was placed on the importance of unifying patriots in our efforts to save the republic and defeat tyranny. We are looking for ideas and suggestions for how to manage and grow our assembly.

Deep discussion ensued on the ideas and process involved with removing ourselves as men and women from the public, all contracts and how the cestui que vie works. See the recording for further details.

Ryan reminded us that we had previously discussed the idea of establishing our own common law court and the need for us all to be bi-lingual in both the legal codes and statutes and common law. Specific goals to institute Constitutional Sheriffs. Discussion was had. See recording.
