Reminder from Ross we are always looking for Pro-Tem moderator, scribe, and bailiff to back up the men and women who act weekly for OSJA.

Open Old Business – Tim motions, Cristina seconds.

Old Business:

-Cristina reads minutes from 8/1/23; vote to accept minutes as read: 6 yeas, 2 abstain, 0 nays;

- due to hand injury, Michele has been unable to type up minutes from 7/25; she will work on this over the next few weeks as her hand begins to heal;

-Treasury update: no update as Michael is not in attendance.

-Public Affairs update: Cristina reports that website is not quite ready but chipping away at it continues; the plan is to add empty file folders to which content can be added;

-Annual in person meeting: Kathy will ask Dr. if we can meet on Sunday September 24th;

News from Counties:

- Kat mentions Dave Roberts is offering to provide secured party creditor documents for \$200; this prompts some discussion about secured party creditor process and negotiable instruments process and whether they actually work on something more than a utility bill, like a mortgage or a loan, as no one has reported success with either of those debts;
- this also prompts discussion about costs; it is suggested that a donation is reasonable to compensate people for their time used to create documents, present information, etc;
- also that it is reasonable to have an even exchange – both parties should give and receive something.
