7:04 Ross starts recording and opens official meeting of OSJA, where we meet to discuss all business and will motion and vote on all matters.

Tim says prayer followed by 15 seconds of reflection.

Bivens is read 3 times by Ross; 3 times no.

Reminder from Ross we are always looking for Pro-Tem moderator, scribe, and bailiff to back up the men and women who act weekly for OSJA.

Open Old Business – Michele motions, Karla seconds.

Old Business:

- Michele reads minutes from 8/15/23; Ryan, Michele, and Cristina point out missing word "cannot" in statement *"Ryan says some people listen to recording each week but [cannot] attend weekly meetings due to day/time conflicts"*

vote to accept minutes as corrected: 8 yeas, 4 abstain, 0 nays;

- Treasury update: Michael states there are no changes;

- Public Affairs update: Cristina reports that the website is live; and there are 2 website expenses for which donations are welcome:

 - \$200 for the graphic artist to create the logo;

 - ongoing expenses from Charlie;

- Annual in person meeting has been confirmed for Sunday September 24 at Reichert's Chiropractic in Reynoldsburg; after some discussion, Cristina motions to vote on meeting start time of 2pm, Tims seconds; motion accepted; vote result is 7 yeas; 2 abstains

- Ross tells us that Beverly in Clermont county has drafted a letter to the sheriff basically pointing out that vaccines are bioweapons and it is his duty to confiscate them; the letter is posted in **one People DOCUMENTS ONLY Room** on Telegram; conversation takes place about other counties using this letter; Cristina points out that a letter to a sheriff must come from someone in that county;

- Ross raises topic of voting on meeting frequency – proposal is to change meeting frequency to every other week; conversation takes place (see recording for details); vote result is 1 abstain, 11 nays; meeting frequency will remain weekly;

Close Old Business – Cristina motions, Joe and Michael second.

Open New Business – Cristina motions, Tim seconds.

New Business:

- Cristina mentions that Lucas county is very active; some Lucas members are in contact with Dave and Ross; she

asks Ross for an update on Lucas county; Ross thinks they are taking some action related to smart meters; conversation about smart meters takes place (see recording for details);

-Cristina also mentions that Felicia Beverly has multiple things coming to fruition beyond just utility bills; Dave is working alongside Felicia; Felicia will share what she has when it is completed;

Close New Business – Tim motions, Joe seconds.

Adjourn – Tim motions, Michael seconds.
