2:08 Ross starts recording and opens official annual in-person meeting, which is also annual election day.

Tim says prayer followed by 15 seconds of reflection.

Open Old Business – Cristina motions, Tim and Michael second.

Old Business:

- Michele reads minutes from 9/18/23; vote to accept minutes as read: 7 yeas, 9 abstain, 0 nays;
- Treasury update: Cristina notified Michael after Tuesday's meeting that she received a \$20 donation specifically designated for Charlie for the website;
- Public Affairs update: no real update aside from the fact that we are here today to vote;
- both Ross and Cristina refer to the comments from recently departed members who stated that they moved to State Nationals because "that's where the numbers are"; in regards to that comment:
 - Cristina points out that 58 founding fathers signed documents while 3 million people lived in the colonies;
