[7:02 pm] Tim opens official meeting of OSJA, where we meet to discuss all business and will motion and vote on all matters.

Old Business:

- Michael reports no treasury updates.
  - Cristina and Ross briefly discuss the website, logo and anticipated forthcoming data visibility.
- Per usual, there is a call to action for anyone able to chip in on the content in all areas of interest such as frequently asked questions, member competency quizzes, all 'blanks' that have been discussed over the last year on the Public Affairs Committee whiteboard on Zoom. **See Zoom and prior recordings.**

- Ross voices the celebration of the successful position transition efforts that came to fruition through September's annual meeting vote for State officer positions.
