Official Weekly Business Meeting
Minutes for Tuesday October 31, 2023

As documented AFTER THE MEETING, BY REVIEW OF RECORDING
by Pro Tem Scribe Cristina.

[6:50 or so] pm Ross starts recording. As attendees all log in, Cristina and Ross point out that they are both on mobile for this evening's meeting.

[unknown pm] Tim requests meeting be opened by someone in prayer.

[minute marker 6:25 of recording] Tim says prayer asking that "by the blood of Jesus to silence all the birds and scramble all communication."

Tim calls for 15 seconds of silence for reflection.

Tim reads The Bivens Call for Declaration of Conflicting Allegiances three times; no response.

Roll Call - conducted by Karla. There were 9 papered members in attendance:

Cristina calls Point of Order that there has been no verbal confirmation that a scribe is 1) in attendance and 2) is prepared to take the meeting minutes. ***There is No response.***

Tim calls for motion to open old business.

Open Old Business – Michael motions, Ross seconds

- Tim requests that Cristina read the minutes from the previous meeting that were taken by the elected scribe, Michele. Cristina reminds all, again, that she is on her phone in the car and therefore unable to read anything back during this meeting. Ross points out that ***only*** the (wo)man who transcribed the minutes is to read back the minutes onto the record.
- Michael reports no Treasury updates.
- Cristina reports that there has been no new activity in the last 7 days in Public Affairs.
- ***Tim reiterates that he made a prior call for the general assembly input on the list of items for Education and states his concern that there has been no progress nor responses.***

- Ross revisits the topic of the call to action on Education for the benefit of those on this call who were not in attendance when it was previously discussed. There are no responses.

Close Old Business – Ross motions, Cristina and Michael second.

Open New Business – Michael motions, Trina seconds.

- Tim states he needs this to be a short meeting then poses the question “What else do you want to see or get from OSJ?” There are no new responses.

- Ross reminds everyone there is a de facto election coming up next week. Complex discussion on the process, the specific issues on the ballot and more ensues. See recording at minute marker 15:15.

Ryan from Franklin County joins the meeting at minute marker 16:48.

- Trina illuminates the importance of the spiritual and psychological aspects of the issues our society is facing and how OSJA can impact others positively. Ross emphasizes this is the foundational attitude all OSJA members need to keep in focus so that we can lead by honorable example.
- Cristina, Margel and Michael all continue the discussion to reinforce that we do **not** exist for the adoration of the de facto, for titles or praise but to live by faith to restore honor and eliminate controversy wherever possible.

at minute marker 24:29 Kat from Lorain joins the meeting.

- Tim asks Kat to read the minutes from last week. Ross clarifies this administrative process for Tim that only the man or woman who took the minutes is to read back their own written record of the meeting.

Tim calls for a motion to adjourn.

Close New Business – Michael motions, Cristina seconds.

Adjourn – Cristina motions, Michael seconds.

At minute marker 26:30 Angie Dussia from Montgomery joins the meeting.
