Tim says prayer followed by 15 seconds for reflection.

Bivens is read 3 times by Tim; 3 times no.

<u>Open Old Business</u> – Michele motions, Karla seconds.

Old Business:

- -Michele reads minutes from 1/2/24; correction noted from Cristina: change "...return *her* calls" to "...return calls from anyone"; vote to accept minutes as read, with correction: 2 abstain, 0 nay, 9 yea.
- -Treasury update from Michael: no updates/changes to report.
- -Education Committee update from Michael no updates; he is still listening to a lot of things and has some ideas; anyone who wants to collude with him should email realfooddude@protonmail.com or call/text him at 513.553.9868
- -Public Affairs update from Cristina: no additional content updates; all books and documents that have been discussed by Ryan, Michael and others have been uploaded to the website; Charley is in the process of determining which software plugin can make that portion of the website a searchable library database; he hopes to have a decision in the next few days;
- -Tim reminds the assembly that Michele has resigned and will no longer scribe after the end of January; does anyone have updates or suggestions on possible scribes?
- -Kathy has reached out to several people, all of whom were not interested; she will keep looking;
- -Tim raises topic of recruiting strategy and says that Ryan had mentioned going to different events to recruit but we don't have any plan like a speech/script/pamphlet; Tim would like to create something, like a short write up on a business card and asks for any ideas on what to write; discussion takes place (see recording) and Tim will post photo of card from Stuart on Telegram for all to see;

Close Old Business – Karla motions, Michele seconds.

Open New Business – Michael motions, Karla seconds.

New Business:

- -Tim raises topics of upcoming events that OSJA could attend for recruiting;
- -Michael mentions Reclaim America Tour but he is not sure of any Ohio dates; also mentions OEFFA.org, (Ohio Ecological Food and Farm Association) has an event in the Columbus area in February; some conversation about OEFFA takes place;

- -Michele knows someone who follows Tore Maras, who ran for Secretary of State and has a podcast called The Tore Says Show; every county has a "Tore Says" group; there may be opportunities for collaboration. as some members of this group are exploring Tactical Civics and formulating implementation plans;
- -Tim suggests Michele get any contact information so we can reach out to some individuals to determine if there are any opportunities for partnership between OSJA and the Tore Says group;
- -Ryan raises issue of non-papered people getting involved in specific events; he recalls non-papered people coming to Reynoldsburg when non-negotiable instrument topic was the attraction; how will we handle someone who wants to become a papered member; having transition events or strategies seems important.
- -Cristina says that the Tuesday 6:15 onboarding meeting, conducted by Ross is the transition vehicle for non -papered men and women interested in joining OSJA who might not necessarily be able to attend a local meeting; this is the transition space for non-papered people; a link to this meeting is in our Telegram chat and will be on the website;
- -Ross states that the 6:15 onboarding meeting resumed in August of 2022; the meeting invite is a pinned message in **one People BUSINESS Chat Room** on Telegram; this link can be copied by a papered member and sent via text/email to a non-papered person who is interested in attending;
- -Tim asks Cristina if Public Affairs has any packets, pamphlets, etc, that are used at events?
- -Cristina says each county has a startup packet, full copies of these documents have been posted for some time on the Telegram documents page, Dave has a few of his own pamphlets, and we have pocket sized copies of the Constitution; also some members have business cards, the template for these is saved and those can be ordered for \$50 per 100 cards; more conversation takes place about materials for distribution at events. (see recording); she adds that is it exciting that more people across the state are getting involved in spreading information about OSJA;
