

**The Ohio State Jural Assembly
Official Weekly Business Meeting
Minutes for Tuesday, March 19, 2024**

[7:06 pm] Ross starts recording. Ross calls for an **emergency** vote for scribe for tonight's meeting.

- Ross nominates Cristina (accepts); all in attendance vote unanimously in favor.

[7:06 pm] Ross opens the meeting explaining the purpose of OSJA is to meet to discuss and vote on all pertinent matters.

- Stephen opens the meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. We follow Robert's Rules of Order for Parliamentary Procedure in our meetings.

Open Old Business – Stephen motions, Kat seconds.

- Cristina reads the minutes from March 12, 2024.
Vote to accept minutes as read.
Abstain: 1, Nay: 0, Yea: 7. Minutes are accepted as read.
- Treasury update (Michael): No changes/ updates.
- Education (Michael): No changes/ updates.
- Public affairs update: Cristina yields the floor to Ross for discussion on website and Dave Roberts on public outreach projects.
- Reinforcement is offered from the Clay Clark event last week in Tulsa (training on podcasting sponsored by General Flynn) that ***we are on the right track, the republic is about to be restored. Please see recording.***

- Ross briefly reminds all of the discussion on update/revision of the Bylaws for accuracy in current positions, conduct, elimination of controversy, and inclusion of a more formal Code of Conduct.

Close Old Business – Kat motions, Cristina seconds.

New Business – Michael motions. Joe seconds.

- Ross opens the discussion on voting day and how the civic participation is the periodic consent to the de facto having taken guardianship over men and women instead of acting under out unalienable rights. Please see recording.
- On the idea of unification with like-minded groups, Ryan opens the States Nationals versus American States Nationals conversation. The power structures of the various groups is discussed. It is pointed out that Anna Von Reitz/ David Straight top-down organizations imply the trade of one set of overlords for another instead of our radical self-responsibility, self-governance format.
- Michael offers that there should be a section in Education to describe the differences between the de facto, States Nationals, American States Nationals and our Assembly. He requests input from all to craft a succinct and thorough presentation.
- Kat emphasizes that the *redress of grievances* IS the pathway to the personal win where Assembly members can share their personal witness with the public as an outreach. AffidavitWarriors.com is promoted as an educational resource in this task. Discussion is had. ***PLEASE SEE RECORDING.***
