

**The Ohio State Jural Assembly

Minutes for Tuesday, April 9, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; nominates Cristina (she accepts); all papered members in attendance vote in favor.

[7:05 pm] Ross starts recording and opens the meeting explaining the purpose of these calls with OSJA: to meet to discuss and vote on all matters of concern to the men and women on Ohio.

- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. **Open Old Business** – Stephen motions, Joe seconds.

- Treasury update (Michael): No changes.
- Education (Michael): See recording.
- Cristina reads the minutes from April 2, 2024.  
Vote to accept minutes as read with minor corrections.  
Abstain: 0, Nay: 0, Yea: 6.  
Minutes are accepted as read.
- Public affairs update: Cristina yields the floor to:
  - o Michael for Beverly in Clermont County's trial-by-jury training; There was the first of a series of Zoom meetings this afternoon at 3:30 pm – 5:00 pm.
