

**The Ohio State Jural Assembly
Official Weekly Business Meeting
Minutes for Tuesday, April 16, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; nominates Cristina (she accepts); all papered members in attendance vote in favor.

[7:**pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. - Treasury update (Michael): No changes.

- Cristina reads the minutes from April 9, 2024.
Vote to accept minutes as read with minor corrections.
Abstain: 0, Nay: 0, Yea: **. Minutes are accepted as read.
- Public affairs update: Cristina points out that there is another Lorain Septic Fee public service information meeting this evening so most Lorain CoS members are likely to be there instead of on tonight's call. She then yields the floor to:
 - o Ross for Beverly in Clermont County's trial-by-jury training this past Saturday; ***Please See recording.***
 - o Ross for discussion on website, continuity management and this Sunday's National Liberty Alliance outreach effort in Lancaster. ***See recording.***

- This segues into continued discussion on updating/ revising of the Bylaws and/ or the Jural Covenant of Office to close loopholes, clarify hierarchy, positions, responsibilities, definitively establish a formal process for elimination of controversy, and include a specific, written Code of Conduct and Code of Ethics.
 - o Cristina directs meeting participants to the proposed single sentence addition to the Jural Covenant of Office clarifying ethics. ***See Telegram Documents Chat Room.***
- As Dave Roberts is not present at tonight’s meeting to remark on his April 2, 2024 promise to provide official closure on the protracted investigation into the controversy between OSJA members culminating on January 16, 2024. Although there was no irrefutable evidence provided, there remains no official report.
