

**The Ohio State Jural Assembly
Official Weekly Business Meeting
Minutes for Tuesday, April 23, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; nominates Cristina (she accepts); all papered members in attendance vote in favor.

[7:03 pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Kat opens the meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. We follow Robert's Rules of Order for Parliamentary Procedure in our meetings (see <https://robertsrules.com/> and <https://www.doi.gov/sites/doi.gov/files/6-roberts-rules.pdf>.)

Roll Call - conducted by Ross. Six in attendance (all papered):

Open Old Business – Kat motions, Joe seconds.

- Treasury update (Michael): No changes.
- Education (Michael): See recording.
- Public affairs update: Cristina yields to Michael for discussion on the previously discussed document created with the assistance of Chat GPT outlining the historic functions of different common law committees (Safety, Correspondence and Inspection); This document will be posted on Telegram in the next few days for general discussion, more concise editing for less verbiage, and better man-on-the-street readability (elimination of legalese).
- Ross reintroduces discussion on the case(s) being built in Clermont County spearheaded by Beverly.
- Cristina reads the minutes from April 9, 2024.
Vote to accept minutes as read with minor corrections.
Abstain: 0, Nay: 0, Yea: 5.
Minutes are accepted as read.

Close Old Business – Michael motions, Joe seconds.

New Business – Michael motions, Joe seconds.

- Fairfield County Committee of Safety was created last Sunday, April 21, 2023. There are now four official members in that county. It was a very exciting meeting with many active questions and answers in the crowd and between existing OSJA members. Kat articulates that one of the meeting attendees had a very common set of questions by many who are motivated to behave ethically only out of fear of punishment. Cristina points out that there is an unedited recording of the meeting posted in the One People RECORDINGS only room.
- Kat discusses an outreach effort that was made on Saturday, April 20th in Southeast Michigan. There were about 30 people there, a handful of them from Ohio. The speaker was discussing getting land patents registered. The conversation drifted to the de facto where Cristina and Kat were sourced quite a bit on the many varied topics discussed in OSJA meetings. Three of the attendees from Ohio sought contact information and the meeting link for OSJA Tuesday 6:15pm onboarding call.
- Beverly discusses her situation in Clermont County and calls again for participants for her Zoom calls prepping for common law grand jury on the cases centered the county's health mandate misdeeds causing harm to herself and her neighbors. Please join her calls; the day and time is flexible weekly; the next scheduled meeting is Monday at 1pm; link to be shared on One People Business Chat. She expresses great concern over the way the de facto has mis-quoted her statements in officially docketed filings on her case(s). Ways to rectify this problem are considered.
- Joe brings up the value of Bill Hermanson's video outlining the many points most people are curious about when first introduced to our goals. All agree this is such a highly informative source. Ross volunteers to break it down into 2-to-3-minute segments for the general public.
- Michael urges everyone to attend the upcoming Bobby Lawrence (disclaimer – he is State Nationals) meeting where he is going to teach on how to access our Cestui Que Vie Trusts. The meeting is on May 18th and 19th in Wixom, Michigan. Tickets are available through Eventbrite for a total of \$161.90 per person.
- Michael and Ross discuss the value and importance of Rod Class teachings on how to become a Private Attorney General. Beverly has recently joined. Rod is a highly valuable teacher and strongly recommended for anyone who feels at all uncertain of how to handle themselves when interacting with agents of the de facto court system. "Well worth the investment in ourselves."
