**The Ohio State Jural Assembly**  
**Official Weekly Business Meeting**  
**Minutes for Tuesday, May 7, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; Michael nominates Cristina, Joe seconds; (she accepts); all papered members in attendance vote in favor.

[7:03 pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Michael opens the meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. We follow Robert's Rules of Order for Parliamentary Procedure in our meetings (see <https://robertsrules.com/> and <https://www.boardeffect.com/> and <https://www.doi.gov/sites/doi.gov/files/6-roberts-rules.pdf>.)

**Roll Call** - conducted by Cristina. Seven in attendance; (six papered):

**Open Old Business** – Michael motions, Joe seconds.

- Cristina reads the minutes from April 23, 2024.  
Vote to accept minutes as read with minor correction.  
Abstain: 1, Nay: 0, Yea: 5.

[7:12 pm] Michael is having connectivity issues and temporarily drops off the call;

- Public affairs update: Cristina reminds all that website content review for 'group voice' is necessary – whether for Michael's Education section or any other part of the site. Michael's Chat GPT document on Telegram needs others to chime in so we can be more understandable to the public. Reminder that last meeting's discussion of Bill Hermanson's video (breaking it down into 2- to 3-minute segments) task is still outstanding.
- Dave updates us on the goings on at the Lorain County CoS due to their attention grabbing Septic System Fee issue. The health board is perpetrating taxation without representation/ missing oaths/ missing bonds. **See recording.**
- Fairfield County Committee of Safety is discussed; Kathy Brooks is contacted for an update and several State members volunteer to help get them settled. The hope is that CoS members will attend the Reynoldsburg meeting day after tomorrow.
- Dave is headed to Michigan to teach a Macomb County constitutional rights/ de jured government class on May 17<sup>th</sup>. Discussion is had regarding attendance, and details of getting lawful CoS settled in Michigan. Michael asks Dave to provide a recording of this course so we can utilize this tool on the Education section of the website. Kat and Cristina discuss attending this day long event. **See recording.**

- Michael rejoins the call.
  - o Treasury update (Michael); nothing to report.
  - o Education (Michael); **See recording.** Michael requests that Dave provide a recording of his upcoming Michigan seminar for our use as a training and recruiting tool on the website.
- Dave reiterates his intention to finalize the investigation report on the January 16<sup>th</sup> controversy within our membership so we can move forward with modifying the bylaws. The goal is to ensure no repetition of the confusion and harm that ultimately led to multiple members resigning.

**Close Old Business** – Stephen motions, Joe and Kat seconds.

**New Business** – Kat motions, Stephen and Joe seconds.

- Dave discusses the book “**Errant Sovereign Handbook**” and how we all ought to embrace its lessons. The PDF is downloaded and now posted on the website in the library.

**This is the single publication, aside from The Constitution, that we must direct men and women to learn and act on, in every instance, to force the de facto to respect and act UNDER common law.** Volumes I and II are available on Amazon for \$45 each or PDF (free) online via simple search.

- Kat explains the details of how the Septic System Fee is the de facto strategy to trespass and violate all constitutional rights and land grab; this is happening in many counties across Ohio. **See recording.**

- Dave addresses Stephen’s questions about details in The Errant Sovereign Handbook, including applying this to our daily life. Discussion is had about critical differences amongst the governance approaches between the three Abrahamic religions: Sharia and Noahide laws in particular.
