

**The Ohio State Jural Assembly
Official Weekly Business Meeting
Minutes for Tuesday, June 18, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; Michael nominates Cristina, Joe seconds; (she accepts); all papered members in attendance vote in favor.

[7:02 pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Ross calls for 15 seconds of silence for reflection.

Education (Michael); nothing to report.
- Public affairs update: Cristina defers to Ross for the summary on the Lorain County Board of Health meeting attended last week by the Lorain CoS and multiple other members of OSJA.
