

**The Ohio State Jural Assembly  
Official Weekly Business Meeting  
Minutes for Tuesday, July 2, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; Michael nominates Cristina, Joe seconds; (she accepts); all papered members in attendance vote in favor.

[7:06 pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Michael opens the meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. **Open Old Business** – Michael motions, Joe seconds.

- Cristina reads the minutes from June 18, 2024.  
Vote to accept minutes as read [with minor correction.]  
Abstain: 1, Nay: 0, Yea: 5.

[7:18 pm] – Kat joins from Lorain County.

- Treasury update (Michael); nothing to report.  
Education (Michael); nothing to report.
- Kat notes that there are minutes outstanding that she will read during another meeting; she is unable to read minutes for this meeting.
- Public affairs update: Cristina defers to Dave Roberts to summarize the Delaware meeting from last Friday, June 28, 2024 with Eric Dingus, and a panel of others from The Republic for The United States of America and the Tennessee republic offering support and instruction to those men and women settled on the land on Ohio.

Many concerns were reiterated, new questions posed, lengthy follow-up and answers to be posted on the One People Business Chat page. **See recording.**

Dave points out that Michigan has corrected it's rogue status; this information was

shared in a meeting with Dave and the panel last Saturday in Michigan. This is critical as it now brings the requirements under the Northwest Ordinance to notice the de facto for the nation to be restored. Dave commits to getting phone numbers of each of the panel members so our chairs can get questions answered directly and free Dave up to do what Dave does best.
