**Roll Call** - conducted by Cristina. Five in attendance; (all papered):

Ross & Cristina – Summit Keith – Fairfield Michael – Adams Joe – Summit

Open Old Business – Michael motions, Joe seconds.

- Cristina reads the minutes from July 2, 2024. Vote to accept minutes as read [with minor correction.] Abstain: 0, Nay: 0, Yea: 5.

- Treasury update (Michael); nothing to report; he intends to get in touch with Dean from Tennessee to get details on how his group spun up their currency and lawful commerce structure.
- Education (Michael); nothing to report; The Republic for The United States of America has a large number of educational details and opportunities that OSJA should connect with on our website.
- Public Affairs update: Cristina defers to Keith from Fairfield about to summarize the Delaware project on the table right now. See recording. Discussion was had regarding the Constitutional Sheriff in Fairfield County Alex Lape; he acknowledged his oath and reassured the public in front of Keith that he IS a constitutional sheriff. Kathy Brooks has been enlisted to help get the readings on the courthouse steps arranged soon so Fairfield County can be officially settled.

- Discussion was had regarding updating the Bylaws and comparing our OSJA covenant to the founding documents declarations on The Republic for The United States of America's website.
- Kat went through the Ohio Constitution (circa 1803) and gave us a first draft version update from maritime/de facto language into current 2024 common law language for our use in treaty with The Republic for The United States of America. Cristina intends to go through the document tomorrow and will then post the second draft for others to look it over and offer comments and suggestions for the third draft update.
