

**The Ohio State Jural Assembly  
Official Weekly Business Meeting  
Minutes for Tuesday, July 23, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; Michael nominates Cristina, Kat seconds; (she accepts); all papered members in attendance vote in favor.

[7:01pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Ross calls for 15 seconds of silence for reflection.

**Open Old Business** – Michael motions, Joe seconds.

- Cristina reads the minutes from July 16, 2024.  
Vote to accept minutes as read [with minor correction.]  
Abstain: 4, Nay: 0, Yea: 7.

- Education (Michael); Had discussions this week with Stuart from Franklin County and Mark Emery from Lighthouse Law to illuminate proper avenues OSJA might take towards potential an ecclesiastical approach to administering the arms-length-clean-hands finances of our assembly. - Fairfield County Meeting is tomorrow at 7pm – upstairs – 941 Meadowview, Lancaster, Ohio. This general CoS meeting is where the time/ day of the week will be established for settling Fairfield! Sheriff Alex Lape has been invited but has not yet responded/confirmed.
- Michael initiated further discussion regarding the individual Jural Covenant of Office for each member and the current protocol for ensuring each man and woman has access to their wet-ink signed verbiage.
- Kat and Cristina have recently reviewed the original (non-ratified) Ohio Constitution (circa 1803) for 2024 updates to common law/ removal of de facto language for our use in treaty with other like-minded organizations, as suggested by Dave Roberts. Cristina will post a draft this evening on Telegram for all other members of the assembly to offer their input. ***Please forward your remarks on this updated document to Cristina and she will coordinate their incorporation into a final version in the next two weeks.*** Cristina will post weekly updates including member's remarks. - Ross opens conversation on the 06/02/2020 version of the State Covenant versus what it ought to look like today based on modified understandings of common law and reflections of the events since June 2020 until today. **The call to action for every papered member of the Assembly is to review the original document, the draft updated Ohio Constitution which will become the OSJA State Settlement Covenant. Please note updates and reflections must reflect the views and goals of every member of the assembly, so kindly send your comments to Cristina via text or email for her to incorporate into a final draft document.**

- Explanation of standard procedures was restated for the benefit of new members.
