

**The Ohio State Jural Assembly
Official Weekly Business Meeting
Minutes for Tuesday, July 30, 2024**

As documented by *Emergency Scribe*, Cristina.

Ross calls for an **emergency** vote for scribe for tonight's meeting; Michael nominates Cristina, Joe seconds; (she accepts); all papered members in attendance vote in favor.

[7:10 pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Stephen opens the meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. We follow Robert's Rules of Order for Parliamentary Procedure in our meetings (see <https://robertsrules.com/> and <https://www.boardeffect.com/> and <https://www.doi.gov/sites/doi.gov/files/6-roberts-rules.pdf>.)

Roll Call - conducted by Ross. Nine in attendance; (8 papered):

Open Old Business – Ross motions, Joe seconds.

- Cristina reads the minutes from July 23, 2024.
Vote to accept minutes as read [with minor correction.]
Abstain: 1, Nay: 0, Yea: 7.
- Treasury update (Michael); Ross reminds everyone that the Zoom account costs \$11/ per month to maintain annually for \$158/ year on behalf of OSJA. Michael points out that donations or expenditures should be reported to him via email at Realfooddude@protonmail.com, subject line: OSJA Treasurer if you have any expenditure or donation to or on behalf of OSJA.
- Education (Michael); Michael draws our attention to the Miki Klahn video posted on Telegram Business chat "Operation Restore the Republic;" Michael points to OSJA's obligation to reinforce statements such as those made in the video with concrete sources. Michael establishes a call to action for OSJA members to compile valid resources. Dave directs attention to the Library of Congress. Please see recording.
- Public Affairs update: Cristina yields to other meeting attendees to speak firsthand to current events. Ross and Keith address the activities of the most recent Fairfield County CoS Meeting where several new members were sworn in. Next meeting is scheduled for 8/21 at 7pm at 941 Meadowview, Lancaster. The Lancaster County Ohio settlement readings are

scheduled each Friday at 2pm for the next month; All papered members of OSJA are welcome to attend.

Dave Roberts shares updates on several Pennsylvania counties who have recently settled under his direction and encouragement.

Discussion is had regarding the update to our Free and Independent Nation=State Covenant update as are periodically necessary. Importantly, the document needs to reflect the thoughts and positions of all Sovereign Electors on Ohio. Dave Roberts kindly requests final draft approval of this document. Please see recording.

Dave and Michael discuss the language in the “original” Constitution from 1787 versus 1789. Dave insists he has located the verbiage online, several participants on the call have unsuccessfully attempted to locate the information online; Dave states that we need to ask a different search engine and use different phrasing.

Ross shares his post from Telegram (Mark Taylor) referencing a governing document known as The Holy Alliance of 1213; Please see recording.

Close Old Business – Kat motions, Michael seconds.

New Business – Michael motions, Keith seconds.

Ross requests Dave Roberts update us on current events. Dave states that during the Lorain County CoS meeting last night, all RUSA required State level positions have been filled, with those Lorain CoS members awaiting approval through RUSA vetting process to accept their titles and positions of authority over the men and women of Ohio through RUSA. Those members are Kat Osker (Governor), Keith Mauger (Secretary of State), Mandi as (Chief Justice); Dave inquires whether Ross has registered under RUSA and applied for the appointment to Chief Justice. Dave insists that everyone must register with RUSA and submit ourselves to Sandy and RUSA. Dave points out that these are voluntary positions on a first come-first serve basis pending elections at some point in the future.

Dave acknowledges that RUSA hasn’t made much progress since 2011 until recently when Dave stepped in. Dave states that RUSA *IS* the lawful government over the citizens of America, urges us all to ACT before the National Guard is rolled out onto the streets all over America within the next ten days because the de facto government is going to be “decapitated” and we will all be placed under Marshal Law for the following 120 days. Dave states that Federal Marshalls are going in to arrest all the de facto actors in Congress and once that happens that government will collapse under its own weight, then RUSA will step in. Dave points out that there are over one hundred people signed up with RUSA on Ohio and none of those names have been shared with OSJA to incorporate those men and women into our Committees of Safety. Questions and answers follow. See recording.

Michael points out that in the last 14 years we have heard dozens of deadlines, promises and urgent calls to action where we have no validation of any promises of rescue by any other organization or person. Multiple meeting participants point to the realities of what our world would look like if we were in a “Continuation of Government” situation. See recording.

Close New Business - Michael motions, Keith seconds.

Adjourn - Michael motions, Keith seconds.
