

**The Ohio State Jural Assembly
Official Weekly Business Meeting
Minutes for Tuesday, August 13, 2024**

Ross calls for an **emergency** vote for scribe for tonight's meeting; Keith nominates Cristina, Joe seconds; (she accepts); all papered members in attendance vote in favor.

[7:07 pm] Ross starts recording and opens the meeting explaining the purpose of these meetings with OSJA members: to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

- Michael opens the meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.

- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. We follow Robert's Rules of Order for Parliamentary Procedure in our meetings (see <https://robertsrules.com/> and <https://www.boardeffect.com/> and <https://www.doi.gov/sites/doi.gov/files/6-roberts-rules.pdf>.)

Open Old Business – Michael motions, Joe seconds.

- Treasury update (Michael); no new activity to report; Donations or expenditures should be reported to him via email at Reafooddude@protonmail.com, subject line: Treasury if you have any expenditure or donation to or on behalf of OSJA.
- Education (Michael); Discussions are taking place with Charles Stewart from Texas and several other individuals connected the Republic.org regarding the monetary aspect of officially designating ourselves as a Free and Independent Nation State Ohio - separate and apart from The Federal Reserve (the de facto). - Public Affairs update: Fairfield County will be reading on their courthouse steps for the second week in a row this coming Friday at 2pm. Please join the gathering if you can!
- Cristina reminds everyone that there are periodic updates necessary to our paperwork as we grow in our knowledge and understanding. Michael emphasizes the importance of careful and succinct use of powerful language in our governing documents. See recording.

Close Old Business – Keith motions, Michael seconds.

New Business – Michael motions, Keith seconds.

- Discussion on which day/time/location is best for annual elections the third Sunday in September; this meeting also seems to be the most effective opportunity for our members to

ratify the updated OSJA documents as well as the pending 2024 State Covenant (Constitution).

- Discussion is had regarding a J6 persecuted woman from Piqua, Ohio, Therese Borgerding and some ways men and women of the Assembly might be of productive use to this family. The official request from our member (Scott Taylor, Montgomery County) is worded in a way that is likely to produce negative results with the BAR Association. Examples of OSJA members who have attempted to use de facto BAR language in their courts resulted in unappealing consequences; we will attempt to rework the document presented by SCOTT Taylor into an affirmation of true fact appeal to the Supreme Court for clemency for Therese Borgerding.

- Ryan opens an extended discussion on the Republic.org and how it aligns with OSJA. Many questions, researched and those still in need of research, are posed. Take away: membership questions the effect on OSJA if we were to put ourselves under Republic.org control via appointment, registration and vetting approval of another organization (unvetted by ourselves) that doesn't comprehend who and what a Jural Assembly is and rejects the language integral to our founding principles of existence and Covenant/oaths language.
