- Public Affairs update:
  1. Fairfield County Settlement readings on courthouse steps were completed last Friday afternoon; the reading before the county commissioners is scheduled for this coming Tuesday morning, September 3<sup>rd</sup> at 9am.

Multiple local concerns have recently been addressed through lawful Notices by the CoS' to appropriate public officials –

- a) Lorain County board of health members on the septic system charge issue third notice was mailed out last week;
- b) Fairfield County has begun the process of noticing their city council members and other city officials for their failure to force compliance with local codes and statutes that would prevent lewd activities in and around downtown Lancaster; Documents scheduled to be signed en masse this coming Friday;
- c) Miami CoS member Scott Taylor's issue brought forward on behalf of Piqua resident unlawfully persecuted by Washington DC courts – blanket Notice of Harm document has been created which can be used for this case and all the other 1,385 unjustly prosecuted men and women who traveled to the nation's capital on January 6<sup>th</sup>;
- d) Updated OSJA documents to be ratified by the Assembly continue to be posted on Telegram. See recording and Telegram one people DOCUMENTS page for each of these notices in its final form.

**VOTE TO ALTER ASSEMBLY PROTOCOL DURING ANNUAL ELECTIONS:**
