The goal today is to begin to determine a structure for Mock Trial [Common Law Court of Claim Hearing] training sessions.

Three examples of structure/roles are discussed, none preferred over another:

Ohio State Jural Assembly, Common Law as framed by Sovereign's Way (Law Common to I – Jennifer Goodwin), Ecclesiastical (Biblical Citizenship), and the writings of Lysander Spooner (An Essay on Trial by Jury);

Structure of what the Court of Claim might or should look like and what each position entails.

Board of Review (3 to 5 people) reviews the evidence to determine if the facts are sufficient to bring a claim for remedy; Grand (or Petit) Jury reviews the evidence and certifies the requested remedy

Positions discussed: Jurists, Jury Foreman (Moderator - one of the jurists), Jury Commissioner (Chief Justice), Magistrate, Clerk of Courts, Sheriff.

Conclusion: Study the Spooner book (PDF available for download at and come back to the next meeting with highlights, questions that arose out of our study and ideas of how we can structure an outline of what educational process is suggested for anyone interested in participating in this process.

All participants are encouraged to evaluate their own common law claims for use as examples in Mock Trial situations.
