10:17 am Cristina begins the recording. Ongoing pre-meeting conversation surrounding a matter in Sheffield Lake where local officials including City Council members and the Law Director where one or more of these people owns a property that they are trying to push through emergency zoning changes to enable a food truck court to immediately be erected one block from Lake Erie and 500 feet from a large and well established quiet residential area.

Discussion on the sections of The Errant Sovereign's Handbook example letters and how those might be used as a template to rescind autographed agreement to accept relinquishing our *homo sapiens* existence and contract to shed against mankind via the 2020 worldwide event. Many details were discussed as to who needs to be held accountable (and how) for the damage that has been done to the man or woman who did not have full disclosure so that they might have agreed (or disagreed) UNDER INFORMED CONSENT.

The men and women in the meeting dive into the spiritual aspects of the damage that has been done. "Consanguinity" and "Homoborg Genesis" are discussed. The magnitude of the task before those who comprehend it must not overwhelm; recognizing the problem obligates men and women to take action to preserve what God gave us - FREEDOM. We trust that as we take each readily understandable step in this process, the next consecutive step will make itself apparent. Holding to our vow to act in peace, to restore honor and eliminate controversy must be our over-arching mindset. Spooner essay highlights the difference between BAR and Common Law jurists: under common law each man and woman is required to exercise their conscience, not just be 'difference engines' evaluating the language of codes and statutes.

The group agrees to switch gears and discuss the variety of case examples we have before us: Septic fees, zoning changes, removal of public officials from office for abuse of authority and how all of these situation have common threads.

- "Harm" by interference with the unalienable rights granted to mankind by God.
- Nobody is impartial or unbiased.
- Mankind is split into two camps – those with a moral ethical God-given conscience who benefit from men and women fighting for unalienable rights and those who anticipate monetary/spiritual gains from the energetic damage being caused.

Treatments for energetic damage are discussed. Sabrina Wallace and her lectures are illuminated.
