- How much more study is needed prior to applying our knowledge to a 'mock case'.
  - What specific points do each of you feel you're weakest on
  - o There can never be enough study when talking about retaining true sovereign jurisdiction on ourselves
  - Where does our authority come from to effect common law in any courthouse
  - What is the procedure we follow/how do we carry ourselves
  - Understand the differences between the forms of law: Maritime, Ecclesiastical, but mostly Equity versus

These actions all confirm that the de facto CANNOT argue against the common law claims made and processed two years and five weeks ago. The 'compensation remedy' clock has been accruing interest since November 22, 2022. The claimant will not present her case to a jury until the de facto complies with it's contracted promise to expunge her record of all charges, which should have occurred no later than September 9, 2023. Judge Hoover refused to approve the expungement, retroactively claiming an extra year of 'secret probation status' which has also expired as of September 9, 2024.

### Food for thought for future meetings:

- View the videos on the Scottish Common Law Court to familiarize yourself with the differences between de facto and common law; this will help you resolve the issue of 'not knowing what you don't know'.
- Contemplate which case(s) will best fit with mock common law jury trials.
- Potential Juror Selection Committee seated under the Grand Jury Commissioner.
- Jural Assembly structure and responsibilities of each chair and how these all mesh together with the process we are attempting to establish, document and provide a handbook for guidance.

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with a mind to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embraceable to the general population.

Everyone participating in these calls, reading the minutes and watching the recordings is called to action in recommending any source of additional guidance and information that could help us structure our process better.
