#### **Guidelines for Jurists**

Ross provides an outline of the Declaration of Independence as a suggested starting point to guide our efforts on a jury.

#### **Oath(s)**

What would a proper oath be for a Board of Review or a Grand Jury; several oath examples are reviewed. Requirement of a firm and clear conscience which requires an understanding that ethics cannot exist without morals based on a firm and clear *single supreme Creator* spiritual foundation. Each man or woman who is requesting a review of their claim should have the right to determine who their peers are by tailoring the spiritual phrasing of the Oath to their own conscience. The goal is to ensure that each jurist comprehends their own sovereignty and will represent that and the spiritual beliefs of the claimant in order to achieve a remedy unique to the specific case.

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with a mind to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embraceable to the general population.

Oath language being considered: OSJA Jural Covenant of Office and parsed Sovereign's Way law common to i language:

**My unalienable Rights are held by Inborn Power.**

I am sentient, affirm with FREE Will, by this covenant, I agree to accept and serve as a JuristI will delegate power, from unalienable Rights held by Inborn Power; If appointed, or elected, to any office serving the People on Ohio, a Free and Independent Nation=State, and I do accept such calling, I will faithfully serve this office; I will uphold, support, preserve, protect and defend my local County Settlement Covenant, Covenant of Ohio State, a Free and Independent Nation=State, the Declaration of Independence, July 4, 1776, and the Constitution 1789 and the Bill of Rights c.1791, and the Ohio Covenant of 2020. I will perform and fulfill all Jural duties, and administer the law of the land on this Free and Independent Nation=State Ohio with respect to mankind faithfully, impartially, peacefully, honorably and never contrary to the Laws of Almighty God. Preferring no one through envy, hatred, malice, covetousness or ill-will, and leaving no one misrepresented out of fear, favor, affection, reward or enticements; Investigating, without reserve or restraint, all matters of knowledge or, which have been brought forth unto me in such impartial capacity; keeping all such counsel and deliberations at all times secret for protection of all mankind.

I solemnly pledge to do all this to the best of my ability and understanding in a sacred covenant between me and those I am about to serve, and our Almighty Creator, so help me God.”

May Heaven and Earth bear Eternal Witness to my oath on this \_\_\_\_\_ day of \_\_\_\_\_ in the Year of our Lord 20\_\_\_\_\_ by the honorable,

I give oath/affirm, that I will be true to serve those of mankind as a woman who serves as an investigator on a board of review; And will do right by any and all of mankind; Preferring no one through envy hatred malice covetousness or ill, and leaving no one misrepresented out of fear affection favor reward or enticement; Investigating without reserve or restraint all matters of knowledge or which have been brought forth unto me in such impartial capacity; I shall uphold the law with respect to mankind faithfully, impartially, peacefully, honorably and never contrary to the laws of almighty God; I shall witness a claim and the facts and evidence to support said claim, and render a recommendation without favor, infection, or ill will.
