Oath conversation continues

Reminder that the various aspects the claimant will need to focus on for their peer jurist(s) to properly reflect what the man or woman bringing the claim believes as their basis of right versus wrong, equity and return to honor.

Michael begins the discussion by pointing out common law language requires the present tense and removal of negative statements. His proposed oath:

i, _____ affirm/give oath that i, am true to serve those of mankind as a wo/man who serve as investigator on a jury/board of review and will do right by any and all of mankind; preferring no one; not being subject to envy, hatred, malice, covetousness, ill-will, fear, favor, affection, reward or enticements; assure that each man or woman is heard; investigate, without reserve or restraint, this matter of knowledge or evidence which are brought forth unto me in such capacity; to uphold the law with respect to mankind, faithfully, impartially, peacefully, honorably and never contrary to the laws of almighty God; i witness a claim and the facts and evidence to support said claim, and render a recommendation without favor, affection, or ill will; so help me God/Creator/universal source.

Diane Mary also proposed a few minor changes; these were discussed along with the specific variations between a formal grand jury, a petit jury and a board of review. The group concluded thusly:

i, _____ affirm/give oath that i, will be true to serve those of wo/man/mankind/man and woman on the land as a wo/man who serves as investigator on a jury/board of review and will do right by any and all of wo/man; preferring no one through envy, hatred, malice, covetousness or ill-will, and leaving no one misrepresented out of fear, favor, affection, reward or enticements; investigating, without reserve or restraint, this matter which has been brought forth unto me in such capacity; and shall uphold the law with respect to all, faithfully, impartially, peacefully, honorably, equitably, and never contrary to the laws of almighty God; i shall witness a claim and the facts and evidence to support said claim, and shall render a recommendation without favor, affection, or ill will; reflecting equal rights and returning every man and woman to honor; so help me God/Creator/universal source.

The group decides that we are ready to hold our first mock board of review, using Michael's recent de facto interaction as our basis.

Michael's oath is utilized. For the purposes of this practice session, the following positions are designated:

Beverly – Magistrate

Michael – Harmed claimant

Cristina and Ross – the de facto agents

Kat, Keith, Judy and John – members of the Board of Review

Michael presents the facts of his case. Much discussion is had regarding the difference between de facto proceedings and all the ways claims are different. The idea of remedy in these situations is almost as important as ensuring jurists share the same spiritual basis of governance. Collectively, educating all members of the de facto (as well as all mankind) in common law, a detailed written apology for the harm and monetary damages at a punitive level yet not so excessive that it is unrecoverable.

GOAL: exist in peace, eliminate controversy - restore honor – operate wholly in the private.
