Statement of Peaceful Intent

I am here only to peacefully engage with fellow common law grand jury members gathering together in peace to grow in our knowledge and abilities to eliminate all controversy and restore honor to all mankind.

By remaining in this meeting I agree that I am here of my own free will, without any outside coercion nor duress.

I have been offered no reward, enticement nor threat to speak or act under the direction of Any man or woman aside from my own thoughtfully researched conscience and facts.

I am not here to instigate nor continue conflict. I understand that I am free to leave at any time.†

If you are unable to agree with the entirety of this statement of intent, kindly exit the meeting now, without fear of backlash or retaliation.

Ross calls for a vote for scribe for tonight's meeting; Cristina is nominated, Keith and Michael second (**Verify at read-back**); (she accepts); all papered members in attendance vote in favor.

Ross explains the purpose of this meeting ✓ to conduct a lawful OSJA paper ballot election; as with all meetings with OSJA members: we are here to meet, to discuss, and to vote on all matters of concern to the men and women on Ohio.

[7:01 pm] Ross starts recording and opens the meeting, Ryan joins the meeting.

- Ryan opens this meeting in prayer.
- Ross calls for 15 seconds of silence for reflection.
- Ross reads *The Bivens: Call for Declaration of Conflicting Allegiances* three times; no response.
- Ross reminds all that according to OSJA Bylaws, we are here to discuss and motion on all topics of interest. *We follow Robert's Rules of Order for Parliamentary Procedure at all times in our meetings* (see <https://robertsrules.com/> and <https://www.boardeffect.com/> and <https://www.doi.gov/sites/doi.gov/files/6-roberts-rules.pdf>.)

ROSS RE-READS THE *STATEMENT OF PEACEFUL INTENT*

[7:10 pm] Discussion is had and conclusively agreed upon by The Assembly regarding the reason, need, and culmination of variety of members»prior demands for lawful process (whether those members are present in tonight's meeting or not). The desired restrictions and requirements placed on aspects of the exact procedure for this paper ballot election by all voices prior to and including tonight's meeting are thoughtfully taken into account. This review included the Bylaws, the waiver to the bylaws, the Bilateral Social Compact and other sources and reasoning, precedents and election verifications/processes whether de facto or otherwise. Reference is made at length to the December 3rd and 10th

statewide assembly meetings, the 12/03 unanimous vote for this lawful election; participants of those meetings and their concerns, and all parties affected by this vote are discussed. It is noted that the Bylaws only discussion of length of term is with regard to the MINIMUM term for the Grand Jury Commissioner of three years. **It is acknowledged by all that each has the obligation to step forward in their own strengths into state positions so that there can be a more fair distribution of workload amongst all members,** circling us back to the need to more clearly define job responsibilities and division of responsibilities.

Collective participation is embraced as the procedure below is unanimously settled upon after lengthy, sometimes awkward deliberation:

- 1) Only those papered OSJA member electors present in the election meeting are eligible to
be nominated/elected or
to have their paper ballot certified by their own voice as having been written with their own hand.

- 2) Mail in ballots are notoriously unreliable and are therefore rejected.

- 3) (Tonight's) Paper ballot by members in good standing must state:

Elector printed name

County

Year they swore their Jural Covenant Oath

*** Future Ballots should include Position for which their candidate(s) are nominated;

e.g., Moderator ✓ Ross ✓ Yea/Nay/Abstain

Pro Tem Moderator ✓ Curly ✓ Yea/Nay/Abstain

Recording Secretary ✓ Larry ✓ Yea/Nay/Abstain

4) When called upon, the elector holds up their ballot onscreen to be noted by all meeting participants, confirmed verbally and be considered ≈certifiedΔby the Assembly.

5) Ballots are to be folded and placed into a secure envelope and mailed to the Statewide Assembly official Post Office Box, addressed to The Lawful Ohio State Jural Assembly, P.O. Box 670042, Northfield, Ohio 44067. Ballots to be picked up 14 days from tonight, confirmed by video documentation as not having been tampered nor interfered with, recording to be posted on official online archival board(s) and paper ballots to be secured for posterity in the State Record Archives. The autographs and thumbprints on these ballots will serve as verification on future votes by same assembly members.

[7:48pm] It is collectively agreed that the Assembly recognizes and certifies a unanimous vote (nine votes from seven counties) in the affirmative for Ross Marley as the Moderator for the State Committee of Safety for the Lawful Ohio State Jural Assembly for the remainder of the Sept. 2024 through Sept. 2025 regular election cycle.

No other positions were voted on tonight; no other votes nor motions will be entertained in this evening's meeting.

Open Discussion

Proposal is made to assure that there is no public misunderstanding that the Lawful Ohio State Jural Assembly has neither been bifurcated nor gone sine die, or any other implication that continuity has been disrupted. This lawful Assembly must author a formal written acknowledgement of the group of 30 OSJA members who have chosen to break themselves off from the Lawful process and procedures of this Assembly and go in a different direction from the original purpose, goals and intent stated in founding documents; emphasis is made on respecting the rights and responsibilities of sovereign adults, particularly in our efforts to self-govern. Formal language to be proposed for discussion next week.

This conversation leads to the vital corrections and updates needed in a variety of areas on founding documents, matter is set to be conclusively discussed as soon as possible in upcoming meetings.

Next meeting is set for Tuesday, December 24, 2024 at 7pm via Zoom.

Sean Beller remarks on behalf of all three observers that the AFR acknowledges their formal recognition of the finalization of the lawful Ohio paper ballot election.
