ALTHOUGH CONTINUITY OF EXISTENCE FOR THE LAWFUL OHIO STATE JURAL ASSEMBLY IS OUR SECONDARY FOCUS, THESE MEETINGS ARE NON-POLITICAL, NOR RESTRICTED TO MEMBERS OF ANY SPECIFIC ORGANIZATION, OR RELIGION.

Bivens is not discussed.

THIS TRAINING IS DESIGNED TO EDUCATE ALL MEN AND WOMEN ON THE LAND IN WAYS TO RETAIN SOVEREIGNTY, BECOME SELF-GOVERNING, EMBRACE COMMON LAW AND THE TRADITIONAL MORALS AND ETHICS WHERE EVERY MAN AND WOMAN HAS AN EQUAL RIGHT AND RESPONSIBILITY TOWARDS THEMSELVES AND EVERYONE AROUND THEM.

The foundation of this all is that there are only two laws given by God to mankind – do no harm and do not trespass.

These meetings are to maintain continuity of OSJA, practice, and preparation for mock trial for Common Law jury training and handbook.

Common Law : the historically known system of God’s law all the way back to and including the Magna Carta, not codes and statutes.

Peer : one who does not share sufficient shared experience and knowledge as the one bringing the claim such that they cannot be considered similar enough to adjudicate in a fair manner.

GOAL: exist in peace, eliminate controversy - restore honor – operate wholly in the private.

First notice to Fairfield County Sheriff Lape is discussed at length.

Peer qualifications are again discussed, including point-of-contact within the Sheriff staff. Specific methods and strategies for language, delivery and other technicalities in the Notices process are discussed.

Lengthy discussion is had regarding shedding, nanotechnology, research and recent admissions in the mainstream media and new federal administration indications regarding side effects and efforts that can be made to mitigate symptoms (frequency awareness among others).

Critical Takeaway: As common law jurists, we must be prepared to set the example to the general public as the example of self-governance before any administrative ‘reach-down’ can be

made. Without a prepared people making up the body politic, there can be no paradigm shift in governing, otherwise complete societal chaos will result.

Discussion was had about timing for Notices delivery to the Fairfield County sheriff and possible face-to-face meeting with a handful of participants on this call. Tentative scheduling of this meeting would be the last week of February, assuming one or two Notices are sent by then.

The jurists on the call were sworn in utilizing the following mutually agreed upon oath:

I, (state your name), affirm/give oath that I will be true to serve man and woman on the land as a wo/man who serves as investigator on a jury/board of review and will do right by any and all of woman or man; preferring no one through envy, hatred, malice, covetousness or ill-will, and leaving no man or woman misrepresented out of fear, favor, affection, reward or enticements; investigating without reserve or restraint, this matter which has been brought forth unto me in such capacity; and I shall uphold the law with respect to all mankind, faithfully, impartially, peacefully, honorably, equitably and never contrary to the laws of almighty God; I shall witness a claim and the facts and evidence to support said claim, and shall render a recommendation or verification without favor, affection or ill-will; reflecting equal rights and returning every man and woman to honor, so help me God/Creator/universal source/dao.

Post-meeting note: If the Sheriff meeting in Fairfield County can be scheduled on a Friday, Doc Anthony from NC has indicated he would like to gather together with our group on an upcoming Saturday in the near future. This could be a sleep-over visit combined Friday Sheriff Lape visit/Saturday Roundtable Zoom if planned effectively.

The possibility of guest speakers from Australia is discussed; also an acquaintance of Beverly's who is aware of the AI technology effects from having been injected may come on one of these calls. Keith suggests a possible discussion with a local funeral home director who is, as yet, not comfortable discussing what he has seen in the last five years because of the circumstances surrounding the 2020 lockdown.

Beverly closes with a reminder that we should all consider composing our own affirmation of our experience. Informal interviews with men and women who have had experiences, transcribed by diligent investigators like us, then requesting the subject confirm accuracy and possibly attest to the verified facts is one successful strategy she has employed and encourages us to consider.

Conclusion: Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with a mind to making the language of the texts we are reviewing more generally understandable, the idea of jurat participation less complicated/modern-day embraceable to the general population.

Everyone participating in these calls, reading the minutes and watching the recordings is called to action in recommending any source of additional guidance and information that could help us structure our process better.

Written minutes, the recordings of these calls and links to future meetings will be posted on Telegram and forwarded through emails provided by participants during the meetings.

Meeting is adjourned at 11:43 am. Next meeting scheduled for Saturday, February 1, 2025 at 10 am via Zoom.
