ALTHOUGH CONTINUITY OF EXISTENCE FOR THE LAWFUL OHIO STATE JURAL ASSEMBLY IS OUR SECONDARY FOCUS, THESE MEETINGS ARE NON-POLITICAL, NOR RESTRICTED TO MEMBERS OF ANY SPECIFIC ORGANIZATION, OR RELIGION.

Bivens is not discussed.

THIS TRAINING IS DESIGNED TO EDUCATE ALL MEN AND WOMEN ON THE LAND IN WAYS TO RETAIN SOVEREIGNTY, BECOME SELF-GOVERNING, EMBRACE COMMON LAW AND THE TRADITIONAL MORALS AND ETHICS WHERE EVERY MAN AND WOMAN HAS AN EQUAL RIGHT AND RESPONSIBILITY TOWARDS THEMSELVES AND EVERYONE AROUND THEM.

The foundation of this all is that there are only two laws given by God to mankind – do no harm and do not trespass.

These meetings are to maintain continuity of OSJA, practice, and preparation for mock trial for Common Law jury training and handbook.

Common Law : the historically known system of God’s law all the way back to and including the Magna Carta, not codes and statutes.

Peer : one who does not share sufficient shared experience and knowledge as the one bringing the claim such that they cannot be considered similar enough to adjudicate in a fair manner.

GOAL: *exist in peace, eliminate controversy - restore honor – operate wholly in the private.*

Discussion is centered around the Stockholm Syndrome psychology surrounding the conversation we need to try to have with those who are resistant to accepting the facts of shedding and other vaccine injuries. Keith points out that Pfizer has a listing on their website (several pages long) that details shedding symptoms.

Fairfield Board of Health – working on second notice now.

Tina is rescinding her consent to the last vaccine she received. “Nunc pro tunc” a phrase from the Errant Sovereign’s Handbook is being used as the basis for clarifying the nature of the ‘contract’ The System has forced on mankind (this would work for all contracts which were not made with our full knowledge and consent. Beverly Wellbourne has template documents she can provide to all interested.

“Geoengineered Transhumanism,” by Elana Freeland, is discussed (she’s got MANY publications of tremendous use to our best understanding). Ms. Freeland has been invited to come and speak to our group.

Alisha is scheduled to speak to us next Saturday; she’s going to speak specifically to the connection between the nanotech in the injection and her soul consciousness.

The many troubling issues surrounding the manipulation of consciousness are touched upon – ‘vaccines’ with the vast majority of ingredients designed to do OTHER THAN what they are promoted as, cell phone & television send/receive technology, Bluetooth devices, routers, 5G, fluoridated/heavy metal tainted water, chemtrailing. Beverly points out we have to start Somewhere, and the vaccine is the easiest to pinpoint A) who is specifically responsible ‘for pulling the trigger’ so to speak and B) most people seem prepared to accept the vaccine has negative consequences.

Joseph Sansone from the Mind Matters and Everything Else Podcast on Spotify (Leon County, Florida) case is discussed. Mr. Sansone filed an Emergency Petition for Writ of Mandamus with the Florida Supreme Court citing the 1989 Biological Weapons and Antiterrorism Act, stating that the mRNA nanoparticle injections violate 18 USC 175 Ch 10 BioWeapons and FS 790.166. Sansone filed a substantially Constitutional (both state and federal) argument against Ron DeSantis and Ashely Moody based on the cardiac problems he developed after becoming a victim of shedding. Sansone is demanding a halt to all distribution of vaccines. The three successively higher courts' responses all indicate, summarily, (in the vernacular) that the government as corporate entities (in the office of the Governor and the Attorney General) has no obligation, and, mankind has no right to be protected from purposeful trespass harms up to and including death.

The point is made that there is a similar case ongoing in Arizona. There are several states whose attorney generals are suing Pfizer, similarly. The response of courts is to reject Mandamus rights, to re-write "Claim" and call it a "Complaint" placing it under BAR rules, and rejecting due to improper language or 'no proper cause'... The fact that the BAR/maritime system is fighting to prevent reversal of ALL prior 'decisions' is abundantly clear.

Several examples of court and local council interactions are cited where public officials state the Constitution is NOT followed ("It's archaic"); in some cases, men and women who insist on compliance are removed from meetings or threatened with being held in contempt.

Conclusion: Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with a mind to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embraceable to the general population.
