THIS TRAINING IS DESIGNED TO EDUCATE ALL MEN AND WOMEN ON THE LAND IN WAYS TO RETAIN SOVEREIGNTY, BECOME SELF-GOVERNING, EMBRACE COMMON LAW AND THE TRADITIONAL MORALS AND ETHICS WHERE EVERY MAN AND WOMAN HAS AN EQUAL RIGHT AND RESPONSIBILITY TOWARDS THEMSELVES AND EVERYONE AROUND THEM.

The foundation of this all is that there are only two laws given by God to mankind – do no harm and do not trespass.

Common Law : the historically known system of God’s law all the way back to and including the Magna Carta, not codes and statutes.

Peer : one who does not share sufficient shared experience and knowledge as the one bringing the claim such that they cannot be considered similar enough to adjudicate in a fair manner.

GOAL: *exist in peace, eliminate controversy - restore honor – operate wholly in the private.*

THIS MANNER OF NOTE-TAKING IS ACCEPTABLE.

Beverly: “...so they just dismiss every case or won’t take the case as a lawful case, etc., just any way at all to keep us from accessing any court. I’ve tried a Federal court and some county courts. I forget if you (there in Australia) call them counties or shires? Anyway, a county or shire court you can’t get in. You just can’t get in anywhere. So we are forming a (common law) Grand Jury, or a jury at least, we have about enough (jurists) for a Petit Jury right now, a jury of twelve. We’re looking at a case and our plan is to try to make the cross-over through a sheriff which is over the counties. We’re just about ready to try to do that but

that's in two weeks. We're just about to go and talk to a sheriff to try to get our (Constitutionally protected common law) court recognized as a court that action can be taken on. We're excited about that, and we also have a lot of trepidation. It's sort of like, if things decay enough in the structure (of our current government) we may be able to make this crossover (from the current Article III maritime courts back to Article II common law courts), and get our court to be recognized as being a court.

So, we're courageous, but we also don't know (how this will all play out) and the people who are assembled here (on this Zoom call) are mostly men and women who could be on a jury, might be on a jury, or already are on a jury, etc. I basically brought everyone I could think of (on today's call) because I wanted them to actually see these lovely microscope pictures of the nanotech (contained in the Pfizer vaccine that you discovered). This is part of my evidence. There are actually several people coming on there to talk to these people regarding some kind of evidence. That includes individual's statements saying that they've been harmed by either direct injection or shedding. We've already heard from some of those people. So this (call today) is part of a whole series of information(al expert speakers we are inviting to talk with our jurists) that goes to the same group (for the purposes of preparing to go to court as a Grand Jury)." Kat: "Would it be okay if we take screen shots with our phones, of this recording and just not video so we can show people the slides so we can show people?" \

Dr. Nixon: "I've got a lot of material on my website (<https://drdavidnixon.com/>). I'm right in the middle of launching a new journal; I don't want (this) to be on the record until I get things finalized."

Kat: "Okay, then I will not record."

Dr. Nixon: "That's why I'm here (talking to you today). You are welcome to take screenshots after the first ten minutes or so. Let me show you what I've been thinking about. I've spent some time this morning just thinking about (what and how to share with you)."

Dr. Nixon then screen-shares his 113+ page journal article, reviewed by a small number of academics, from His 'The Journal of Bionanotechnocracy' which will be published on his website in the next few days.

The paper summarizes his research for the last three years. His professional experience for 25 years as a general practitioner in both New Zealand and Queensland, Australia. Beginning in early 2022 he began prescribing Ivermectin and caught the negative attention of an increasing number of medical industry regulators. Importantly, in Australia & New Zealand, for a time, those practitioners who were members of the Royal College, designated as specialists, for a time had permission to write temporary exemptions for patients on the vax mandate; this government permission was terminated after six months, where he had written upwards of a thousand exemptions. After attending a meeting with many other like-minded physicians in Australia where a 25 year experienced blood-analyst discussed recent startling anomalies in blood samples, Dr. Nixon felt compelled to conducted a clinical experiment using a partial sample of Pfizer vaccine.

The gathering had many intriguing questions for more than 90 minutes about this experiment, the results, what Dr. Nixon speculates/projects the possible ramifications of his research might be.
