Grand Jury now - bring indictment  
against DeWine -

More powerful than the Assembly  
accusing him.

Gives us 21 days once we send the Remonstrance to the Supreme Court.

Elect the \*commissioner.  
picks out the jury pool  
Assigns the 4 investigators.

25 members 1/25. 3 year position

end of 2<sup>nd</sup> year - appoint a 2<sup>nd</sup> Commissioner - he trains him.  
Appoints the members that he needs.  
can choose outside of Assembly too.

Gary says form Complaint as a Replevin - not Complaint,  
Remonstrance - don't create an argument - State damage -
