I will uphold, support, preserve, protect and defend my local County Settlement Covenant, Covenant of Ohio State, a Free and Independent nation=state, Declaration of Independence, July 4, 1776, and the Constitution 1789 and the Bill of Rights c.1791, and the Ohio Constitution of 1803. I will perform and fulfill all Jural duties and administer the laws of this Free and Independent nation=state with respect to its people faithfully, impartially, peacefully, honorably and never contrary to the Law of Almighty God; Presenting no one through envy, hatred, malice, covetousness or ill-will, and leaving no one unrepresented because of fear, favor, affection, reward or enticements; Investigating without restraint all matters of knowledge or which have been brought forth

unto me in such impartial capacity, keeping all such counsel and deliberations at all times secret for protection of the People. I solemnly affirm to do all of this to the best of my ability and understanding as a sacred covenant between me and the people I am about to serve, local to this free and independent state, and the Almighty Creator, so help me God."
