[7:10 pm] Recording begins, meeting is opened, Ross states our mission;

The Ohio State Jural Assembly is a never-for-profit, private membership association. We require that each meeting participant embrace the Statement of Peaceful Intent, comply with the Bivens Declaration of Conflicting Allegiances, and, at all times, follow Robert's Rules of Order for Parliamentary Procedure, each being incorporated in its entirety by this reference;

- Accept the proposed agenda.

The agenda is read aloud. No additions requested under Unfinished or New Business. Request is made by Cristina to pass over the JCO until the next meeting to allow additional time to finalize recent edits; also item XV. b. on the agenda was covered last week and should be struck. Unanimous acceptance of **these requests.**

Open Old Business – Kat motions, Michael seconds.

Prior meeting(s) outstanding minutes are read for consideration of factual **accuracy**, acceptance onto the record after discussion.

- Minutes from February 20, 2025 (with minor corrections);
Abstain - 0, No - 0, Yea - 8; the minutes are adopted onto the Record;

Officer Reports

Treasury – Keith: Ross needs to meet with Keith on previous activities. No other activity this week.

Chair Reports

Education – Michael. No changes this week; he continues research.

Public Affairs – Cristina. Aside from the website, there were a couple of matters that came up this week that the assembly should consider: first, Destry mentioned last Thursday evening that Alaska and Michigan have a BLSC with Reciprocal recognition for trade; Cristina has reached out to Michigan and Alaska initiating talks to establish the same between Ohio and those states, to assure inter-state cooperation regarding trade, ‘etc.’. The existing Ohio BLSC template is lacking a handful of very important aspects including references to prohibition of chemtrails and EMF/other frequency manipulations, etc. There have been requests that we gather in Fairfield County again as a group for multiple purposes – re-affirmation of the new Jural Covenant oath, meeting with the sheriff, allowing for the Michigan delegation to come discuss official recognition by National Assemblies and inviting a delegation from North Carolina (Saturday gathering is necessary for NC participation). Beverly’s schedule seems to be most restricted so Keith will coordinate days/times and let us know when (hopefully by the end of March). Website – please review, make comments, suggestions, additions, objections and the like so we can finalize and authorize the content of the site at the next meeting (March 6, 2025).

Keith suggests a “find my county CoS” page for easy access of County CoS contact information. Michael requests inclusion of Yusef El’s “SPC University” link (website is paid membership access only) or YouTube channel to be linked on the Education page.

Special Committee Report No report is ready at this time. JCO and DRP moved to next week.

Unfinished Business

- Follow up on last week’s Bylaws update on resignations process and acknowledging those who recently decided to go a different direction than the assembly. Documents are ready to be sent back to those men and women; simple postage is requested. Kat volunteers to fund the project. Cristina will email Keith confirmation of the transaction for treasury records.
- Verification of Paper Ballot from Judy Durham from the January 14th election for Grand Jury Commissioner.
- Re-confirmation with Michael that both the JCO and the DRP need to be passed over, as they still need a finalizing discussion. These will both be voted on for acceptance by the general assembly next week.
- Stark County prior actions. Further discussion about evidence provided on this negative action by the State against the most active members of the Stark County CoS in 2021 (the most active county at that time). Multiple files were finally located and posted late last night which must be reviewed to guarantee that the assembly has finally practiced full and responsible due diligence. The argument is presented that we should not delay more than one more week, as this matter is several years old. Agreement is reached that as much as most of us are heavily inclined to reverse and apologize for these previous actions, the most responsible path is that the evidence must be reviewed and rationally considered prior to the final vote on Kat’s motion from February 13, 2025 to retract all prior punitive actions against any member of the Stark County CoS. Kat motions to table the matter for one week. Seconded by Keith.

- Bilateral Social Compact for the counties with reciprocal recognition of the state. No counties have moved or had much discussion on this matter. This is the document that formally grants the State the **right and** authority to house the Grand Jury. Previously the only county that established this document was Lorain (no paper record of this can be located). Matter is tabled to next meeting. Motioned by Keith, seconded by Kat.
- Subcommittee volunteers are needed to evaluate and compare the Ohio Bylaws rules and procedures to the North Carolina Bylaws rules and procedures for purposes of finalized update of OSJABL.

Close Old Business – Motioned - Cristina; Second – Michael.

In the interest of time there is **no New Business** discussed in tonight’s meeting;

Informal wrap-up discussion on the following two old business items:

- The quarterly gathering in Fairfield County is further discussed. Beverly’s schedule and the availability of the dance studio are primary.
- Report from Keith on current Grand Jury Commission activity on his claim against the local Board of Health on their promotion of vaccines even in the **face** of overwhelming evidence of the dangers and harms. Response from these officials ranges from complete disregard (Sheriff) to varying levels of shirking of responsibility, regardless of the sections of the Ohio Revised Code that clearly state responsibility of those local officials. Multiple claims for trespass onto common law claim are discussed (esp. the city law director, the prosecutor and the claims examiner). **PLEASE SEE RECORDING.**
