Today’s guest speaker, Arielle Schmidt, talks about the vaccine injury symptoms she has been suffering for the last several years, especially how she tracks the specific infective interaction(s).

Michael and others talk about the inclusion in ALL injectable pharmaceuticals of heavy metals and other toxic substances.

Lengthy, emotional conversation is had amongst all meeting participants about the difficulty faced by those who recognize they’ve been/are being harmed by the clients and loved ones they interact with who have been vaccinated. Concerns of those of reproductive age are discussed.

Beverly initiates the subject of Aufstellung Therapy. From Brave AI:
