Participants each verified the claim of the man, Keith, against those members of the Fairfield County Board of Health, responsible for ensuring safe practices for public health policy in Lancaster OH. The claim presented by Keith is attached at the end of these meeting notes.

Letters have been written to the five authority figures in that governmental structure: Tina Childers (Township Trustee/County Recorder's office), Don McDaniel (Mayor), Joseph Ebel (Health Commissioner), Crystal Warner (Immunization Nurse), and Steve Davis (County Commissioner).

Several members of the Board of Review indicated the desire to communicate with Donald Trump to implore him to support American LEO's by retraining them be Constitutional. This letter should be paired with a letter to the Sheriff thanking him for his efforts to protect mankind on Fairfield County to be secure in their bodies (the multiple homicide, massage parlor – human trafficking operations) BUT the will of the people is explicit that his efforts to secure mankind in their bodies MUST be extended to include the right NOT to be microwaved by 5G, poisoned in the air and soil by chemtrails, assaulted and poisoned by being injected with proven toxins, and the like.
