## Officer Reports

*Treasury* – Keith: Discussion of **Grand Jury expenditures** is had: Expenses for the four mailings to officials on Fairfield County pertaining to this claim are declared:

On January 30, 2025 postage of \$ 100.15 was incurred in the current Grand Jury case;

On February 5, 2025 postage of \$ 100.15 (same reason – 2<sup>nd</sup> notice);

On February 10, 2025 postage of \$20.31 (same reason – 3<sup>rd</sup> notice);

On February 21, 2025 postage of \$ 100.15 (same reason – 4<sup>th</sup> notice)

On March 7, 2025 postage of \$ 33.20 (same reason – 5<sup>th</sup> notice)

bringing the **total expenditure to date on this case to \$353.96**

(Administrative reminder: the idea of a privately secured trust account designated exclusively for the purpose of sustaining OSJA activities is being investigated. A report will be forthcoming in the future for general assembly decision making).

## Chair Reports

*Education* – Michael. SPC University and C2K Report (YouTube) are strongly recommended at this time; research continues and vetted sources to expand our base for the public and newcomers will be forthcoming, along with Michael’s summary report. The Educational Resources page on the website is in constant update as additional resources are located.

*Public Affairs* – Cristina. Recommendations this week on matters of concern to Ohioans:

- a) Waiting to hear back from contact given to us by Destry to receive template documents and process to ensure that OSJA did in fact complete all steps in “The Michigan Model”;
- b) Charley confirms the security and increased activity of the website in recent weeks; we are up from less than ten visitors a week to about 40+ per day; Document upload is regularly being updated, without hackable autographs or full names on any of the published documents to prevent doxing or identity theft.
- c) Pasco, Washington and State of Maine - achieved legislative movement to ban vaccines;
- d) Prohibition of Glyphosate in any form on Ohio (incl in County BLSC?)
- e) Utah and other states - Prohibition of Fluoride in water
- f) Tennessee - Prohibition of chemtrails
- g) Florida - Banning of vaccines in foods
- h) Cleveland group working to amend the Ohio State constitution on property taxes;

Charley is helping to research these topics and successfully locate exact documents filed by these groups for replication on Ohio;

Anthony Pena (“Doc Kek”) has generously agreed to come on this call next week to discuss county Bilateral Social Compacts so the above topics can be documented as ‘the expressed will of The People;’ Expectations in the future are that as North Carolina refocuses the greater part of their assembly energy towards settling more counties, their Telegram “Committee of Safety Starter Guide” is likely to grow into some sort of greater web presence which Ohio will cooperatively promote on our website.

Ross inquires about preferences on the Glossary document. Brief viewing of several pages on the website on educational topics.

Cristina yields to the assembly for further input and discussion.

Special Committee Report Grand Jury Commission update (Beverly is not present this evening to give GJ report). – Keith updates on his claim; letters to officials went out late last week. Keith is working on his letter to Trump, Bondi, Kash Patel and others (joint chiefs of staff? JAG?) (which we should all be individually composing).

2. Bilateral Social Compact for the counties with reciprocal recognition of the state. North Carolina’s Communications Secretary has offered to come on the call with us next week to explain the process they followed in NC (Buncombe County) and do Q & A. This idea is approved by the assembly.
3. Subcommittee to compare Bylaws “Rules & Procedures” between Ohio/NC volunteers still needed.

1. What project does the assembly want to focus on next?

New Topics discussion. Multiple new topics are presented, most have been brought forward in other states with some measure of success in attaining legislative recognition:

- a. Prohibition of Glyphosate in all forms (Ohio State Health Commissioner – Bruce Vanderhoff)
- b. No Fluoride in the water (Utah)
- c. No Chemtrails (Tennessee)
- d. No vaxxing (Maine and Pasco, Washington)
- e. No vaccines in food (Florida)
- f. Cleveland group working to amend state constitution on property taxes (Keith Davey with Citizens for Property Tax Reform)
- g. Ohio Advocates of Medical Freedom (Ross’ close friend) “many projects” gathering March 29<sup>th</sup> (See Recording).

Proposal is made that members review this list of suggestions and either select one that we can work together on as a whole or decide on small groups (3+ members) to work on several topics at the same time; conclusive discussion to take place next meeting.
