Treasury – Keith: Updates on treasury activities: the following notations are made for the public record:

- Annual website hosting fee (Due September 1 annually) is \$270.00; (paid by Ross)

- September/March post office box charge has increased since last September \$100 to \$103 every six months. (Paid by Ross)
- There was a recent periodic clerical supply charge of \$16 for color printer ink cartridge (printing of Bylaws for the archives) (Paid by Cristina)

<u>Reminder</u> a) expenses directly related to conducting the business of the Assembly NEED to be reported, whether the member is seeking reimbursement or not. As we grow, the transparency of this process may come into question if we are expecting (for example) donated spaces to accommodate drastically larger groups or weekend events, such as that which the North Carolina Assembly is already periodically hosting. [It IS reasonable to anticipate that Ohio will have the same, if not greater, interest in the near future as we continue to achieve publicized successes].

Chair Reports

Education – Michael. No changes to report at this time.

<u>Public Affairs</u> – Cristina. Recommendations this week on matters of concern to Ohioans:

- a) Still haven't heard back from Michigan's communications secretary on getting actual language included in the documents listed on https://michigandejure.org/m/state-settlement/michigan-timeline-2018 which appear to be hyperlinked but are not. Research did reveal "The 10 Step Process" from The Michigan Model which Ohio is almost entirely complaint with, just a couple more simple notifications to various entities are required to be at the same level of credibility attributed to Michigan. As contacts and exact addresses are located, the documents (as outlined here: https://ohio.juralassembly.org/establishment/) will be presented for acceptance by the general assembly;
 - b) Charley additional currently un-utilized features of website (He was unable to attend.
- c) Suggested projects that other communities have achieved levels of success in (listed below) were intended to be "thought provoking" and not intended to be directives. Cristina asks assembly members to chime in on what is most important in their communities:
- Kat emphasizes ridding our environment of glyphosate (all pesticides) and other industrial toxins.
- Michael supports this and adds fluoride in the water, radio frequency manipulation, cell tower (5G) microwaves which are all intertwined and harming the health of mankind, our food sources, land/air/water.
- Keith agrees with Michael's summation, ordering vaccines/chemtrails/cell tower microwave frequencies all at number one on his list of toxic activities that need to stop. (Cell (5G) towers being the only one Keith perceives as a local matter.)
- Ross points out that Idaho has just enacted legislation protecting healthcare workers from being involved in activities they feel are harmful to the health of the man/woman (employee).
- Cristina re-iterates Kim's initial concern that local Chambers of Commerce are being privatized, for profit, taking the responsibility of serving the needs and desires of the population out of the hands of the elected and

placing it into for-profit corporations. This happened in the late 1990's in Lancaster, leading to the situation we fought against last summer/fall.

These matters should each be summarized for inclusion in County Bilateral Social Compacts as well as individual actions undertaken at both state and county level.

Discussion is had about website traffic, how to manage and track interest, how/where to focus attention to gather possible interested parties, "etc.". Further conversation is had about educational links on the website; the assembly votes affirmatively to allow sharing of the most recent link emailed out by The Sovereign's Way introductory Free course.
