Today's topic was the book, "Are Wireless Devices Really Safe: Or, is Wireless Radiation Harmful?" written by Jeanice Barcelo https://wildrumpusbooks.com/book/9781671153431. The conversation included sonograms, ultrasounds, germ and virus theory and modern medicine's typical protocols. Many tie-ins between use of these frequencies and the resulting symptoms/illnesses were illuminated. Lengthy discussion was had.

Tips for efficient interviewing of witness is covered. Beverly guides us to approach this process from an observational perspective. The goal is to get the man/woman to discuss at length and in as much detail as possible. Excellent discussion on this topic – view recording at around the 50 minute mark forward.

Conclusion: Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with a mind to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embraceable to the general population.
