- I. Today's topic was a real-time interview with a woman who experienced three vax related deaths in her family in 2020 as well as many shedding experiences. Physical, psychological and spiritual aspects are revealed. Lengthy discussion was had.
- II. The idea of an 'informal' experiment that could be conducted by the public was posed:
 - Whether or not your dog/cat is vaccinated, observe without interference, the way they react to men and women who are vaccinated. Document these real-time interactions (with as much detail as possible) over a period of time (at least three observations over at least 4 weeks) and submit your observations in writing to a central data collection point (email to comsec@ohio.juralassembly.org) for a larger evaluation. (All documents to be stored as anonymous submissions reflected only with a number known to the comsec (no names or locations), kept electronically without tracking information of the test subjects; on the 'back office archive' of the website, unpublished, and continually evaluated & statistically compared by Michael for his periodically posted reporting.)
 - Bill Gates presented the idea to an MIT class (and or possibly an alphabet agency meeting?) about the affects of certain formulations of injected chemicals on the brain to permanently reconfigure or mute religious responses – video needs to be located. (Charley?)
 - The National Radio Quiet Zone (NRQZ) is a 13,000 square mile area in the United States where radio transmissions are restricted to facilitate scientific research and military intelligence gathering. This zone spans parts of Virginia, West Virginia, and a small part of Maryland. About half of the NRQZ is in West Virginia and the other half in Virginia. The Green Bank Observatory in Pocahontas County, West Virginia, and the Sugar Grove Research Station in Pendleton County, West Virginia, are key facilities within this zone;

- III. Update on the Fairfield County Board of Health (Ohio Board of Health) claim process, notices, and future actions. Resignation of the head nurse on the local BoH (Crystal Warner she had always opposed promoting vaccines). Conversation with Brian Oliver, a County Trustee, sits on the County Board of Health; he revealed that he, too, has always opposed promoting vaccines. Mr. Oliver had wanted to encourage the use of Ivermectin in 2020 but 'got shot down' by all the other members of the BoH (who are all state certified medical doctors). In depth conversation on this and many other aspects of the claim, and the mechanics of carrying out the hearing is had.
