**GOAL:** *exist in peace, eliminate controversy - restore honor – operate wholly in the private.*

**Common Law** : the historically known system of God’s law all the way back to and including the Magna Carta, not codes and statutes.

**Peer** : one who shares sufficient experience and knowledge as the one bringing the claim such that they can be considered similar enough in mindset to adjudicate in a fair and equitable manner.

**I. Today's topic was a real-time interview with a woman describing her interactions with medical professionals in the last few years, specifically as they were interwoven with PCR tests and all other aspects related to the "mandates" model of "healthcare". Physical, psychological and spiritual aspects are revealed. Lengthy discussion was had. A second participant was so encouraged in becoming aware, through this group talk, that she also shared similar struggles and interactions that she, too, shared testimony with the group. It was deemed that both definitely have claims to press, and we are here to assist should they choose to move forward in that way.**

- **Many** high value resources were shared during this conversation –including potential health supporting efforts we can take on our own behalf.

- Multiple participants requested that the list of shedding symptoms document be re-sent to the current entire email list of participants.
- Various EMF protections are discussed.
- It was suggested that County bilateral social compacts include requirement that water purification infrastructure be updated to technology that will clear all toxic chemicals (manmade or natural) and hormones.

**III. Update on the Fairfield County Board of Health (Ohio Board of Health) claim process, notices, and future actions. One of the members of the BoH did, in fact, resign during the period of time noted on Notices for her to avoid being pursued further in this claim; another man also casually reached out to disclose that neither he nor the resigned woman had been in agreement with pushing the "mandates"; Keith is formulating a communication to both to determine whether they might provide written affirmation of these facts.**

**Reminder that each man/woman who did present evidence in this claim should kindly complete their own (3 sentence maximum) summary for inclusion in the final presentment; assignments on the remainder will be forthcoming via email from Beverly.**

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of juror participation less complicated/more modern-day embraceable to the general population.
