Ross states **our mission – to assemble as equal voiced sovereigns, peacefully seeking to learn, to eliminate controversies, and to restore honor for mankind, in keeping with the unalienable rights as outlined and protected by the First Amendment of the Constitution;**

The Ohio State Jural Assembly is a never-for-profit, private membership association. We require that each meeting participant embrace the Statement of Peaceful Intent, comply with the Bivens Declaration of Conflicting Allegiances, and, at all times, follow Robert's Rules of Order for Parliamentary Procedure, each being incorporated in its entirety by this reference;

OSJA Weekly Business Meeting Minutes 2025 – 04 10

Reminder a) expenses directly related to conducting the business of the Assembly NEED to be reported, whether the member is seeking reimbursement or not. As we grow, the transparency of this process may come into question if we are expecting (for example) donated spaces to accommodate drastically larger groups or weekend events, such as that which the North Carolina Assembly is already periodically hosting. [It IS reasonable to anticipate that Ohio will have the same, if not greater, interest in the near future as we continue to achieve publicized successes].

b) any monies voluntarily offered to help reimburse for these necessary Jural Assembly expenses, or any other OSJA expenses (gathering space rental, annual recurring Zoom, etc.) should be forwarded directly to the person who made the purchase on behalf of OSJA, and subsequently reported to **treasury** in detail via email addressed to **keithmauger740@gmail.com** with “OSJA TREASURER” in the subject line.

Chair Reports

Education – Michael. Nothing new to report at this time.

Public Affairs – Cristina yields her update of Statewide activities to those members on the call who elect to report on their own county’s activities. Keith updates on the status of his Notices to the Fairfield County Board of Health and related men/women. **See Recording.**

Special Committee Report - Grand Jury Commission update (Beverly is not present this evening to give GJ report). – Keith updates on his claim; two of the initial recipients of these notices have been removed as they clarified that they were never in support of the vaccine mandates. **See recording.**

Take away: OSJA has achieved a 20% resignation rate of those either elected or appointed to voluntarily represent the community; this statistic comes out of the lawful Notice process we have been effecting to peacefully petition our public servants for redress of grievances (case citations – Macedonia/Stow municipal courts (one directly attributable removal), Lancaster City Council (one resignation), and Fairfield County Board of Health (one resignation, one acknowledged dissenter)).

Unfinished Business

1. OSJA State officers job descriptions – Each officer is to compare the two written descriptions for their position (to be posted on Telegram by Ross) and update based on what the assembly currently expects and requires of them. Once these are drafted, the matter will come back to the general assembly for finalization.
2. Bilateral Social Compact for the counties with reciprocal recognition of the state. Keith and Cristina are in process of meeting(s) to hammer out a strengthening of complimentary language between State BLSC & the County document is updated and more powerful document that protects the men and women on the Counties in the most modern and comprehensive way. Several topics not outlined in the State are: prohibition of chemtrails, drone spraying of crops,

removal of all chemicals from water sources, rejection of AI control over any and all computerized infrastructure systems, and (due to the overturn of the Chevron Decision), specific revocation of consents to any real or imagined authority of NGO's over We, The People, and the final section where the County denotes their recognition of OSJA as the Grand Jury judicial body for Ohio.

Take away: The men and women on the land inside the metes and bounds of each county jurisdiction on Ohio NEED NOT BE MEMBERS OF OSJA to express their will to local public servants through autographing their county (and the state) Bilateral Social Compact!

3. Stark County re-join. Although the apology has been accepted and Steven indicates his group's approval of the course correction Ross and the state assembly has taken since last September, he is dealing with some personal matters, and has not yet gathered the other members of the Stark COS to discuss and conclude their final decision.
4. Fraudulent website. No action has been taken against Amanda, nor has she responded by taking down the fraudulent website that promotes Dave Roberts and leads the public to believe untruths about OSJA. It is the consensus of all assembly members that Ross needs to take any and all actions to get the website taken down. Ross to update when responses and results are seen.
5. Lancaster County Flag Day celebration 'Outreach'. OSJA sponsoring at the Red Level (\$250 expenditure) is discussed. Having t-shirts for our Assembly members to wear when manning the table and handheld 3" x 5" "peace" flags to distribute to participants from our table is discussed and agreed upon. Keith to update on these two expenditures as exact amounts are determined and as donations from assembly members come in to finance.
6. Michigan Model. Because we have not yet shaken the stigma created by Dave Roberts abhorrent behaviors and false statements that OSJA is "HIS ASSEMBLY" Destry will not acknowledge that Ohio is the model assembly that has followed each step required. The removal of the false website advertising Dave Roberts is a key step in restoring honor to OSJA. Alaska and Michigan are now involved in a personality conflict/power struggle similar to what Ohio dealt with last year, the goal of 'getting Destry's blessing' must be put on hold and instead we should focus on the remaining few documents needed to be sent off to various international organizations showing proof that Ohio is de jured.

Kat suggests that there be a specific repudiation of Dave Roberts and other groups which we disagree with on the website, similar to the way Alaska and Michigan have posted publicly. Periodic discussions on this subject have been had since last September, originating with members of assemblies in several other states. Their opinions ("the public") are that the mention of specific names (Anna Von R, Bobby L@wrence, etc.) strengthens the bond between all parties involved, regardless of OSJA disavowal. Although the website, and the parent site, mention several times in different ways who we are and what we are about, there is a need to elaborate further without sullyng our name and distracting from the peaceful, honorable frame of mind required to embrace our

principles. Cristina offers to replace the buttons on the main Ohio.JuralAssembly.Org page denoting bilateral social compacts in reciprocal recognition of Michigan (or Alaska) with a page listing “WHO WE ARE NOT...” to be named “Affiliation Notice” The matter is tabled for further discussion in the future.

- 7. Constitutional Sheriff Survey. Cristina needs to update this survey and will post in Telegram.
